NAME CHANGE FOR THE ACCESS CALGARY APPEAL BODY

EXECUTIVE SUMMARY

On 2015 August 24, Access Calgary, a division of Calgary Transit, took over the operations of the Calgary HandiBus Association. To recognize this change in operations, and as part of the Corporate branding initiative, Access Calgary was renamed Calgary Transit Access.

A change of name is now required for the Access Calgary Eligibility Services Appeal Board to reflect the above name change of Access Calgary to Calgary Transit Access.

ADMINISTRATION RECOMMENDATION(S)

That the SPC on Transportation and Transit recommends that Council:

1. Endorse a name change of the Committee of Council currently known as the 'Access Calgary Eligibility Services Appeal Board' to the 'Calgary Transit Access Eligibility Appeal Board'.

PREVIOUS COUNCIL DIRECTION / POLICY

The existing appeal body and eligibility criteria for Access Calgary were originally approved by Council on 2001 April 02, Report TTP2001-14.

The current name of the appeal board was approved by Council on 2009 March 09, Report LPT2009-14.

BACKGROUND

Every year, Calgary Transit Access provides over one million trips to nearly 15,000 Calgarians that cannot use Calgary Transit services due to a disability. Calgary Transit Access now uses two methods for delivering service. Three private sector service providers provide the majority of trips for Calgarians with disabilities – Checker Cabs, Southland Transportation and Care Calgary. The rest of the trips, done previously by Calgary Handibus, are now delivered by an internal division of Calgary Transit Access.

Eligibility for service is determined on a case by case basis, based on physical and/or cognitive ability to use regular Calgary Transit services. Decisions on eligibility can be appealed to the Access Calgary Eligibility Services Appeal Board.

Over the past few years, Access Calgary has received feedback from customers and the Access Calgary Advisory Committee about the lack of branding and marketing of Access Calgary services offered by Calgary Transit. In addition, customers had difficulty distinguishing clearly between the role of Access Calgary and its transportation service providers.
