Being a Bylaw of The City of Calgary to adopt the new North Hill Communities Local Area Plan 18P2020 and to repeal Bylaw 7P99, the North Hill Area Redevelopment Plan, Bylaw 17P96, the Crescent Heights Area Redevelopment Plan, Bylaw 20P2006, the Winston Heights-Mountview Area Redevelopment Plan, and Bylaw 24P2017, the 16 Avenue North Urban Corridor Area Redevelopment Plan.

Second and third reading were withheld on 2021 June 21 and Administration was directed to return to Council pending review for alignment with the Interim Growth Plan by the Calgary Metropolitan Region Board (CMRB). This tabulation is to advise that the CMRB has reviewed the Interim Regional Evaluation Framework application for the proposed City of Calgary North Hill Communities Local Area Plan (Plan). The CMRB deemed the Plan consistent with the objectives of the Calgary Metropolitan Regional Interim Growth Plan and recommended approval on 2021 July 22.
