

Background

Previous Council Direction

At its 2015 July 27 Regular Meeting, Council adopted the recommendations of Report PFC2015-0518 and gave three readings to Bylaw 30M2015 to: (a) implement qualifications for the position of Subdivision and Development Appeal Board (SDAB) Chair, (b) authorize Council to appoint the Chair, (c) establish term limits for SDAB members, (d) prohibit the appointment of Councillors to the SDAB, and (e) facilitate other succession-planning measures.

At its 2016 May 16 Regular Meeting, Council considered Recommendations of the Selection Committee for Leadership of the Calgary Subdivision and Development Appeal Board (SCS2016-0398) and amended the SDAB Bylaw to allow for the mid-term appointment of public members. It also appointed Mr. Bill Chomik as a member of the SDAB effective 2016 May 17 and as Chair of the SDAB for the period of 2016 July 01 to 2016 December 31.

At its 2016 December 19 Regular Meeting, its 2017 November 20 Regular Meeting, its 2018 October 22 Organizational Meeting, its 2019 October 28 Organizational Meeting, and its 2020 October 26 Organizational Meeting, Council reappointed Mr. Chomik as Chair of the SDAB for 2017, 2018, 2019 and 2020, respectively.
