Background

Previous Council Direction

In 2016 September, the former General Chair of the Calgary Assessment Review Board ("ARB" or "Board") resigned after many years of service and Council established a Selection Committee for Leadership of the Assessment Review Board (SCA2016-0837).

Council considered the recommendations from the Selection Committee at its 2017 January 23 Regular Meeting (SCA2017-0047), and appointed Mr. John Mathias as General Chair effective 2017 April 01. At its 2017 February 13 Combined Meeting, Council subsequently made amendments to the Calgary Assessment Review Board Bylaw, Bylaw 25M2010 as amended, to incorporate Mr. Mathias' appointment to the Board into the Assessment Review Board Bylaw, effective 2017 April 01.

At its Combined Meeting on 2018 March 19, Council repealed and replaced the Calgary Assessment Review Board Bylaw with Bylaw 15M2018, to:

- end the requirement to reflect Council's appointment of members and the General Chair in schedules to the Bylaw;
- align member and Assessment Review Board Chair appointments with changes to the *Municipal Government Act*; and,
- further align member and General Chair appointments with the calendar year, so Council could make these appointments through its annual Organizational Meeting.

At its 2018 March 21 Strategic Meeting, 2019 October 28 Organization Meeting and 2020 October 26 Organizational Meeting, Council reappointed John Mathias as General Chair for 2019, 2020 and 2021 respectively.
