Dear Mayor Nenshi and Councillor Sutherland:

I am writing this letter to you in my capacity as President and CEO of the Van Horne Institute. The Institute is recognized within Canada and internationally as a leading institute of public policy, education and research in transportation, supply chain and logistics, and regulated industries.

We have shared with your office, a number of papers, which we have developed to inform the process undertaken by the Honourable David Emerson to review Canada's transportation policy and make recommendations on same to the Federal Minister of Transport.

The papers researched by the Institute have, in the widest sense, been designed to demonstrate the importance of transportation and transportation infrastructure to the economies of this country. Transportation is an enabler of economies at the national, provincial and community levels.

We fully recognize that Calgary is the transportation and logistics hub for Western Canada. The Institute has run a series of conferences over the last 12 years, designed to explain and celebrate Calgary as a transportation hub. Your Worship was kind enough to be a Keynote Speaker at such a conference. We know that if a company wishes to distribute to the country as a whole, they will establish two major distribution hubs: one in Mississauga, Ontario, and the other in Calgary, Alberta. The Calgary hub has specific strategic cost advantages, which will allow it to expand upon its status as the second largest transportation and logistics hub for Canada. The Calgary Region can, with justification, describe itself as an inland port. Inland ports work in a collaborative, synergistic fashion with the seaports, ensuring that the international trade corridors work efficiently to enhance Canada's import and export capacity. This simply means that our westcoast seaports offload the inbound containers onto rail or trucks destined to Calgary and to the other inland ports that have developed across Western Canada. The containers, once received by the inland port, are distributed from their respective hubs into their hinterland.

There is no question in my mind that the transportation and logistics sector in this region continues to grow. The number of distribution centres in the Calgary Region have increased,

and even when there is a withdrawal from the market, i.e. Target, a new major distribution hub is established, i.e. Home Depot.

Because there is a defined cost advantage to locating a distribution centre in Calgary and the Calgary Region, this growth will continue, notwithstanding, the downturn in the oil and gas sector.

The Institute, with its educational partners at the University of Calgary, SAIT, Bow Valley College and Mount Royal University, see a continuing growing demand for knowledge-workers at all levels in the supply chain and logistics profession. Our research has shown that the jobs offered are still greater in number than the number of potential employees currently being trained through the educational system. The Institute is working with the Calgary Board of Education to include a program in supply chain and logistics at the secondary school level.

It is also clear that with the downturn in oil and gas, there are large numbers of workers who have skillsets that can be transferred into jobs in the supply chain, transportation, and logistics sector. The identification of these skills and connection into the supply chain, logistics sector is worthy of more detailed attention.

I am pleased to support the plans of Calgary Economic development to accelerate diversification in our local economy. I believe that CED's plan to build on Calgary's existing strength in supply chain, logistics and transportation, including warehousing and distribution is a good strategy, and the Van Horne Institute will participate vigorously.

The City of Calgary is home to an ever-growing number of innovation driven companies (IT, clean tech, bio tech) that have served to increase the diversification of our economy. However, over the past number of years the tremendous growth in the cyclical oil and gas sector has over-shadowed the successes of the innovation sector. With the recent downturn in oil and gas, the opportunity now exists to accelerate building and growing the innovation sector which will result in a better balanced and more stable municipal economy. The oil and gas sector has been and will be good for Calgary again, but a more diversified economy has clear advantages.

Dear Mayor Nenshi & Councillor Sutherland:

I understand that consideration may be given to a one time increase to the budget of Calgary Economic Development (CED) in support of its operating plan and key initiatives associated with it.

As discussions take place surrounding this important decision, I thought it might be helpful to offer a perspective from my vantage point as Alberta's Senior Representative for the Asia Pacific Basin, based in Hong Kong. A principal dimension of my role is to engage leadership level commercial actors and investors across key Asian markets in an effort to increase Alberta business partnerships that bring jobs and prosperity to Albertans.

During my time in this role it has become clear that Asian investor interest in Alberta remains high and that new opportunities for Alberta are emerging. As our resources industries innovate and diversify, we are seeing keen interest by established and new Asian players to become part of this exciting story. We are also seeing, however, that there is increasing investor interest in a range of sectors that appeal to Asia's rapidly growing urban middle class or that are important to sectors that service this demographic. These include tourism, education, food, medical technologies, the full range of environmental equipment, services and knowledge, specialized engineering services, entertainment industries and much more.

I am writing this letter to let you know that Calgary is a particular focus of interest for the Asian business leaders I engage with on a daily basis. Calgary has some brand recognition, growing air links, is known to be a Western Canadian center for expertise and services and is closely identified with Alberta's rich natural beauty.

But many of the opportunities before us will remain unfulfilled if we don't work to identify the most compelling business leads, cultivate these relationships and convince Asian commercial actors to cross the business finish line in making actual investments, in creating new distribution channels, in buying our products, in sharing technologies and in helping us to innovate and modernize.

I have been deeply impressed by the strategic orientation of CED, in its integrating and convening role, and the calibre and energy of its leadership and its staff. CED has quickly become a go-to ally and partner for me but also for the wider network of Alberta International offices in Asia. Working together with CED in investor fora in Asia, in support of business missions to Calgary, in developing up-to-date and actionable business intelligence, in presenting a compelling Calgary business and quality of life narrative in rapidly changing times, and in cultivating high priority identified relationships is proving critical to our ability to protect and enhance the livelihoods of our communities and our families.

I know that I will be working closely with CED going forward. And I am confident that it will make a difference to the well-being of many Calgarians and to the province as a whole. It is also evident that CED's impact in attracting investment and in supporting Calgary-based companies to partner in the important Asian marketplace depends to an important degree on its ability to access funding.

I sincerely hope that you give careful consideration to what this funding support can do to help Calgary capitalize on existing and new business opportunities based in Asia. Our successes will not happen automatically. If I can ever provide assistance to Calgary Council in support of these deliberations, I hope you do not hesitate to let me know.



Dear Mayor Nenshi and Members of Council:

I am writing in support of Council's consideration of establishing an Opportunity Fund in the amount of \$7 million to be administered by Calgary Economic Development.

I was honoured to be appointed nearly three years ago, as Chair of the Project Advisory Committee for the Refresh of Calgary's Economic Strategy. This appointment came as the Calgary Poverty Reduction Initiative, which I co-chaired, was preparing its final recommendations. I didn't realize it at the time, but it soon became abundantly clear how closely connected and intertwined these two initiatives were and continue to be. As you are aware, one of the significant differences between the 2008 Strategy and *Building on our Energy*, which was approved by Council in December of 2014, is the significant focus on People and Community Energy in the refreshed strategy.

I was subsequently asked by The Mayor and Council to assume the role of Chair of Calgary Economic Development in May of 2014. I was honoured to be considered for this role and delighted to accept.

Since my appointment as Chair, there have been enormous changes at CED and unfortunately, also significant shifts in Calgary's economy.

Mary Moran was appointed President & CEO in June of 2015, and has been working tirelessly since that time to build her team and focus the organization to become fully aligned in order to execute the *Building on our Energy* Strategy.

In this same time frame, we have had new governments at both the provincial and federal level and a deteriorating economy.

On the positive side, we have improved relations with the City at both the administrative and political level. Jeff Fielding has joined our Board, and Jeff and the members of his Administrative Leadership Team sit on the Leadership Implementation Team for the Economic Strategy, as does Chima Nkenderim.

We have reached out to the Provincial Government and have established strong ties with the new Economic Development & Trade Ministry. They have embraced the Economic Strategy and see it as a perfect framework for advancing our economy in these difficult times. The Minister and his Deputy have been involved in helping to frame the Economic Summit scheduled for February 25th and both will be attending and will play an active role.



We have also made initial inroads with the new Federal Government through Minister Kent Hehr and look forward to further strengthening economic development connections with him and his colleagues.

Community and business leaders have been reaching out to us with their concerns about the economy and suggestions for a path forward. We have shared the pillars of the Economic Strategy with them, and it has been unanimously agreed that the Strategy provides a perfect framework for dealing with the challenges we face.

When we were presenting our annual report to the Priorities & Finance Committee in December of 2015, many of the above observations were made. In addition, I advised that our resources were stretched very thin. Our budget is such that despite our best efforts we cannot take on additional tasks that our governments, the community and businesses would like us to. We obtain some of our funding from the private sector and as you can imagine, those funds are under great pressure in the current environment. The question is also being raised as to whether it is even appropriate for a government agency to be competing for funding from businesses with other not-for-profits.

I believe the initiatives outlined in the Opportunity Fund proposal are appropriate. They are not new initiatives. They are, in fact, elements of the *Building on our Energy* Strategy. The \$7 million in new funding will help us to accelerate these elements of the Strategy.

Each of the initiatives is important. There has, however, been some confusion regarding the Innovation initiative and questions as to why Calgary Economic Development would take the lead with this. This will in fact be a collaboration between Innovate Calgary, the Calgary Chamber of Commerce and ourselves. As you are aware, all of the Actions contained in the Strategy require collaboration among various agencies, not for profits and business. If we are to truly up our game to create an Innovation culture in Calgary we need all hands on deck. We need to connect those who are doing good work in Calgary with one another; we need to build better bridges between post-secondaries and business; we need to identify funding sources; we need to improve governance processes and simplify regulatory regimes. This is innovation in the broadest sense of the word and we need to try to get buy in from governments, business and community organizations, if we are to succeed.

I believe one of the most important things for any organization is strong governance and I have tried to focus on ensuring sound governance practices at every organization with which I have been involved. I think we had good governance practices at Calgary Economic Development when I joined the organization but to me it is a matter of continuous improvement. We have added some strong members to our board and I believe we have a strong, capable and engaged board of directors.

We are committed to ensuring there will be strong and appropriate accountability for the funds entrusted with us through the Opportunity Fund.

I am sorry I will be unable to attend the Council meeting on February 22nd as I will be out of the country. I thank you for the confidence you have placed in me and in Calgary Economic



Development in the past and I assure you we will steward these funds appropriately and effectively.

While our economic conditions are extremely challenging, they also present opportunities for us and it is incumbent on us to work with you, your provincial colleagues, and Calgary business and community leaders to chart the path forward within the framework of the Building on our Energy Strategy.

Thank you very much for your consideration of the Opportunity Fund proposal.
