

#### **Background**

- Council Policy (CFO013 Reserves) and Administrative Policy (FA-50 Financial Reserves) approved in 2010
  - Include a Triennial Reserve Review process
- Every reserve is to be reviewed at least once every three years
- Review is conducted by an Administrative Reserve Review Committee

#### Calgary Purpose of Triennial Reserve Review

#### Ensure that:

- Reserve activity meets all authorizing documents requirements;
- Reserve activity is in accordance with City reserve policies and procedures;
- The reserve's purpose, conditions and/or restrictions are still relevant; and
- The reserve is still required in its current form.
