## BYLAW NUMBER 72M2021

### BEING A BYLAW OF THE CITY OF CALGARY TO AMEND NUMEROUS BYLAWS TO REFLECT AN ORGANIZATION REALIGNMENT

\*\*\*\*\*

**WHEREAS** Council has considered report C2021-1619 and has decided to pass this amending bylaw;

**AND WHEREAS** the proposed organization realignment described in this report is scheduled to take effect January 1<sup>st</sup>, 2022.

### **NOW, THEREFORE, THE COUNCIL OF THE CITY OF CALGARY ENACTS AS FOLLOWS:**
