NOTE:

A technical error in the wording of Bylaw 40P2015 resulted in the unintentional deletion of multiple subsections in Subsection 337(1.2) of Land Use Bylaw 1P2007. The deleted subsections contained rules which allowed projections in only one side setback area of a single detached dwelling and prevented them from being located in either side setback of a semi-detached dwelling. The correct wording was identified in the accompanying report, and it was the understanding of Council that these subsections would be retained in Land Use Bylaw 1P2007. This tabulation is to correct the technical error and retain

the affected subsections.

Background: The Public Hearing for Bylaw 40P2015 was held at the 2015

November 09 and 10 Combined Meeting of Council.
