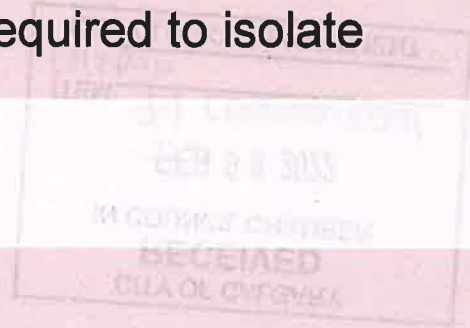

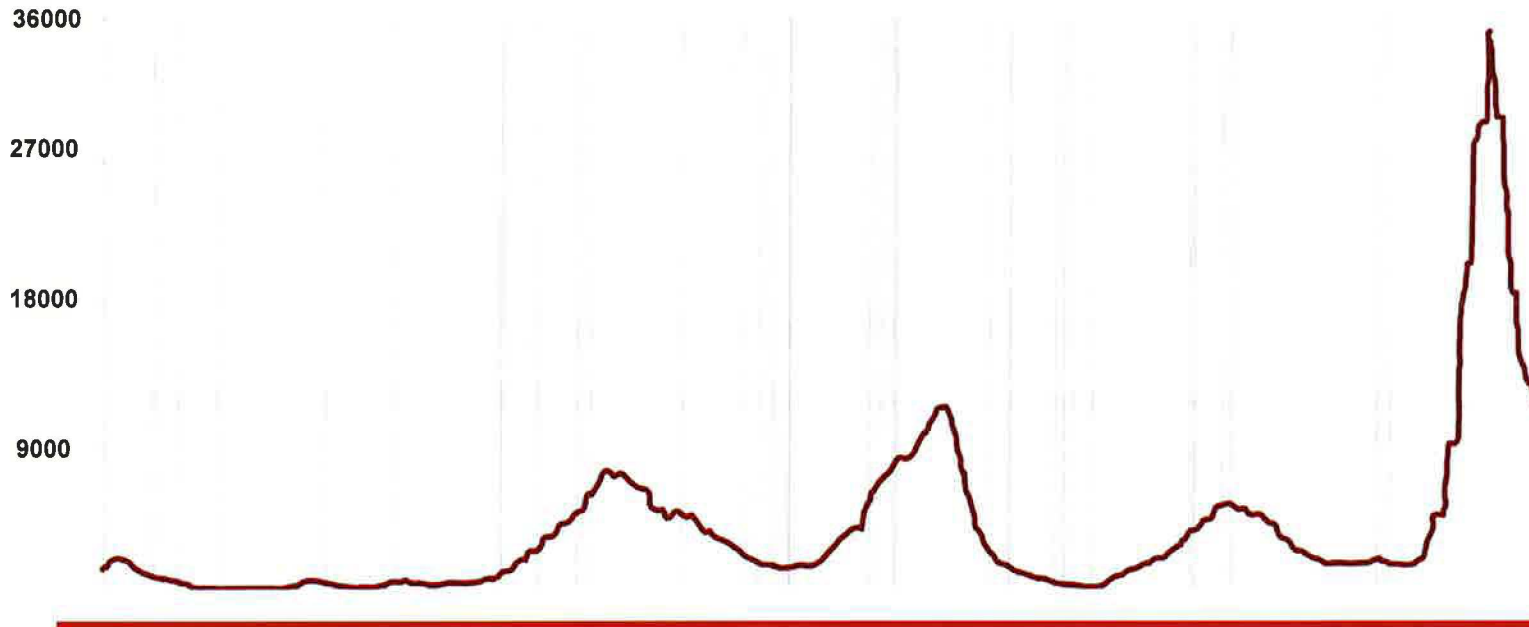

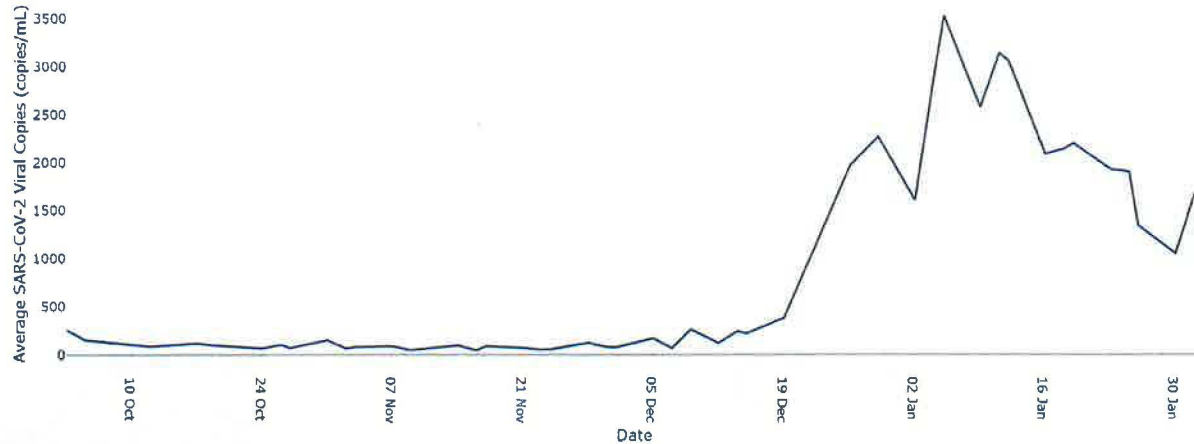


COVID Update: Case Trends

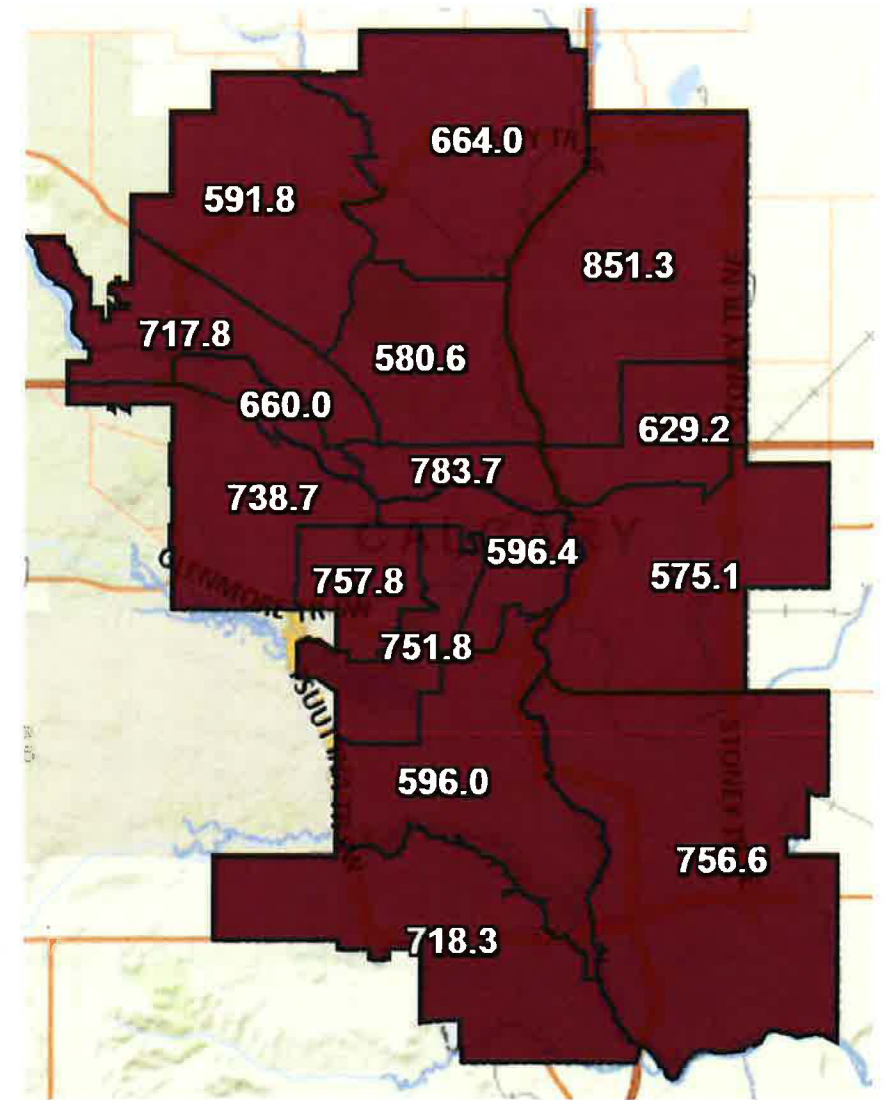
Active Cases, Calgary Zone



Wastewater Monitoring: City of Calgary



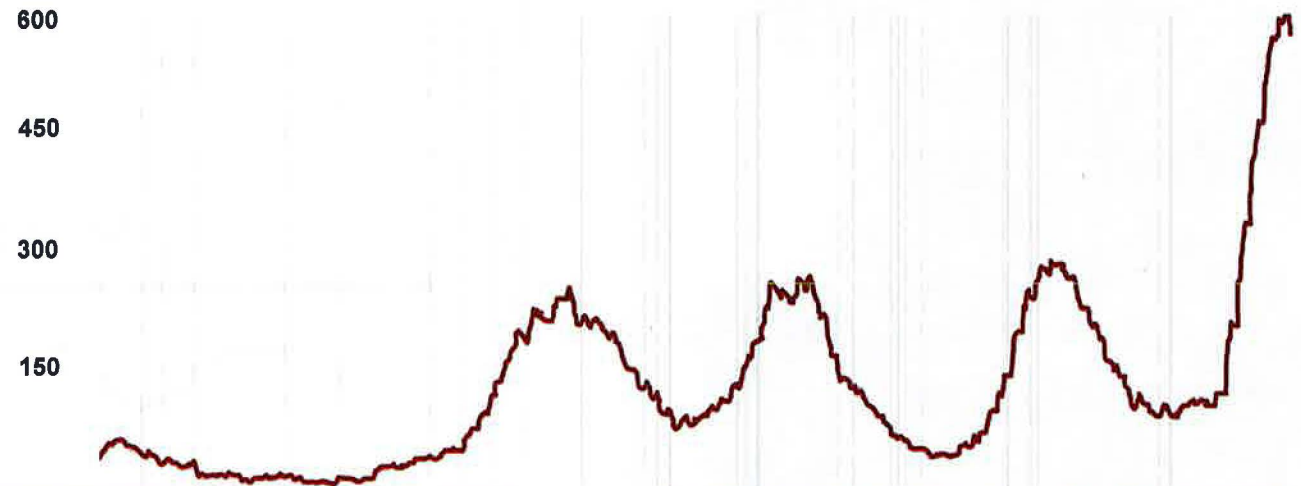
Regional Indicator: Cases/100k Population



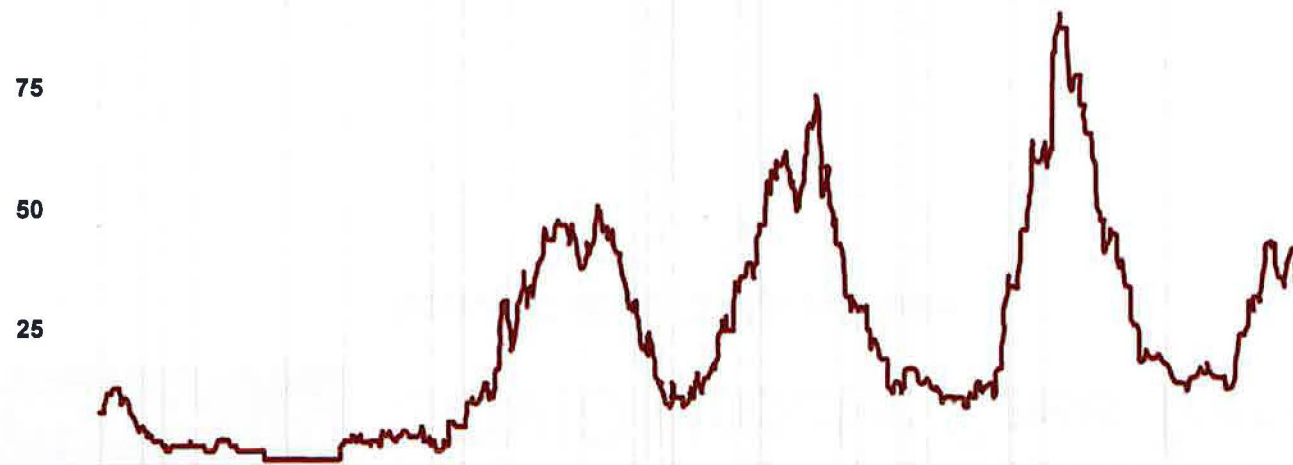


COVID Update: Severe Outcomes

Hospitalizations, Calgary Zone: 597

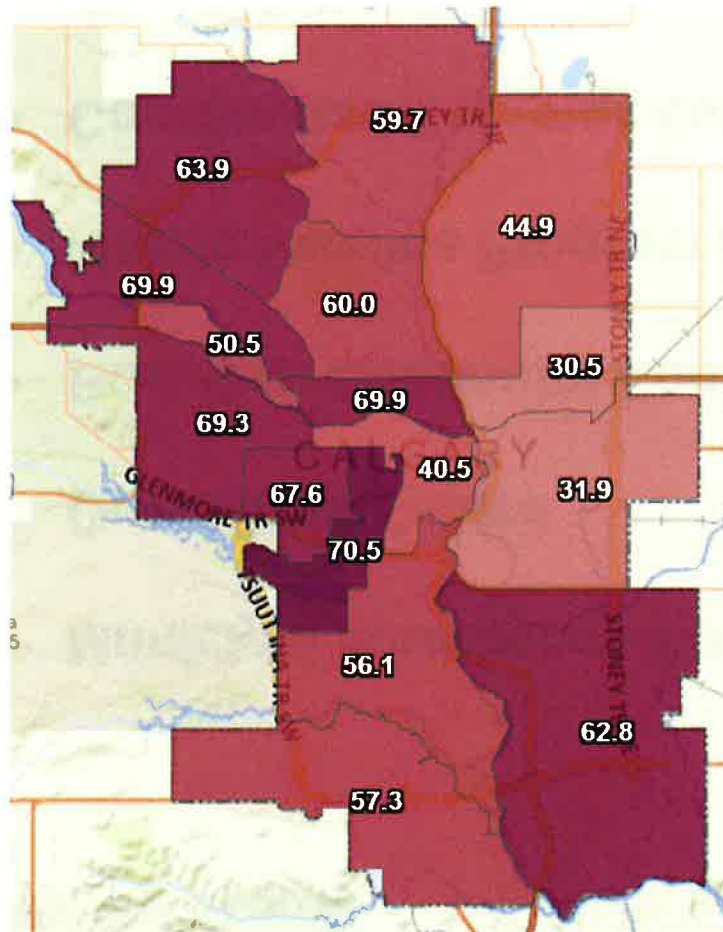


ICU Admissions, Calgary Zone: 44

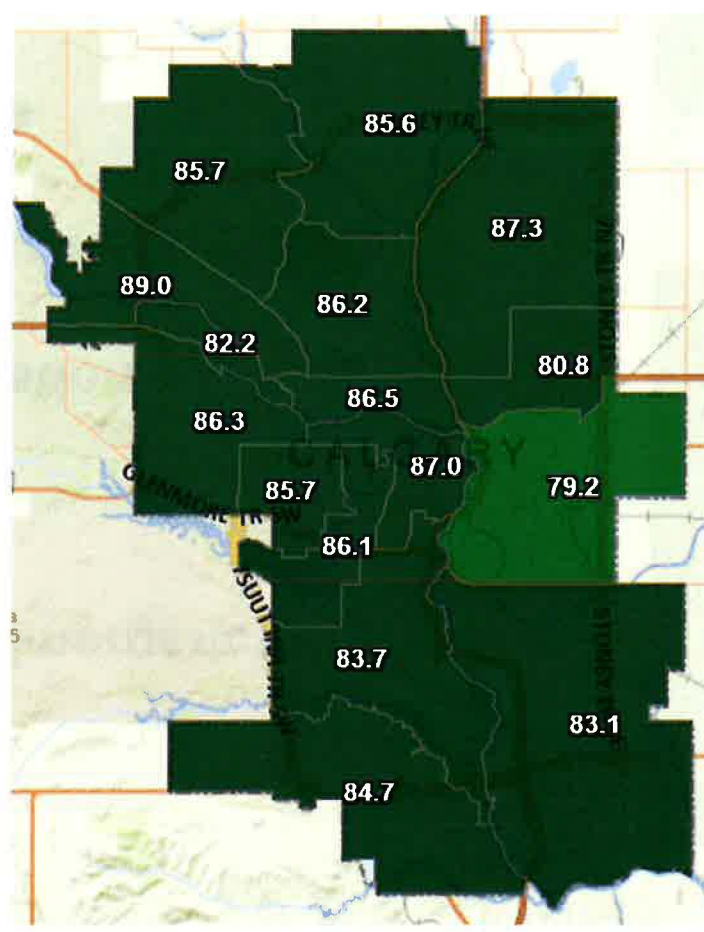

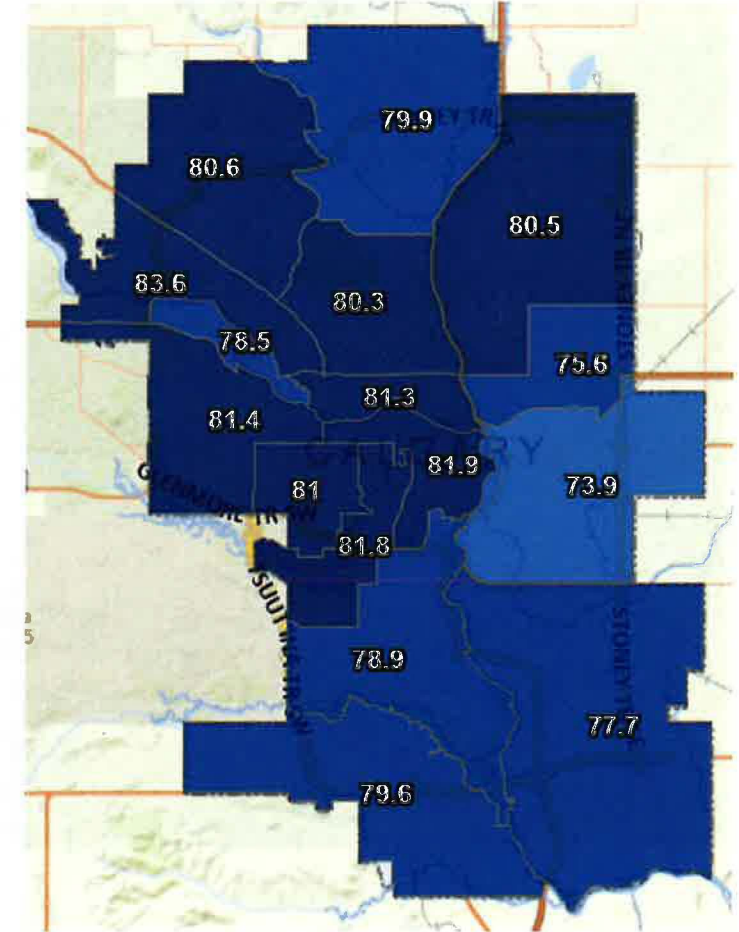
Percentage of Population 5-11 with First Dose
