**BEING A BYLAW OF THE CITY OF CALGARY  
TO AMEND BYLAW 39M84,  
THE 17<sup>TH</sup> AVENUE RETAIL ENTERTAINMENT  
DISTRICT (RED) BUSINESS REVITALIZATION  
ZONE BYLAW**

**NOTE:**

Bylaw 3M2014, previously amended Bylaw 39M84, to change the name of the Business Revitalization Zone from “Uptown 17” to “17<sup>th</sup> Avenue Retail Entertainment District (RED)” as requested by the Board of the BRZ. The Board subsequently advised that the form of name requested was in error and should have been “17<sup>th</sup> Avenue Retail & Entertainment District”. This is a non-controversial housekeeping amendment to correct the name of the BRZ.

**Background:** Bylaw 3M2014, which previously amended Bylaw 39M84 to change the name of the BRZ to “17<sup>th</sup> Avenue Retail Entertainment District (RED)”, was passed on January 13, 2014.

Excerpt from the Minutes of the Combined Meeting of Council, held 2014 January 13:

“ADOPT, Moved by Councillor Farrell, Seconded by Councillor Woolley, that the Priorities and Finance Committee Recommendation contained in Report PFC2013-0820 be adopted, as follows:

That Council give three readings to Proposed Bylaw 3M2014 to change the name of the Uptown 17 Business Revitalization Zone to 17th Avenue Retail Entertainment District (RED).

INTRODUCE, Moved by Councillor Farrell, Seconded by Councillor Woolley, that Bylaw 3M2014, Being a Bylaw of The City of Calgary to Amend Bylaw 39M84, The Uptown 17 Business Revitalization Zone Bylaw, be introduced and read a first time.
