# Subdivision and Development Appeal Board Public Member Appointment

## **RECOMMENDATIONS:**

That Council:

- 1. Appoint the candidate recommended in Attachment 1 as a public member of the Subdivision and Development Appeal Board, for a one-year term from February 15 to December 31, 2022;
- 2. Direct the City Clerk to make the appointment publicly available following candidate notification; and
- 3. Direct that the closed meeting discussions and Attachment 1 remain confidential pursuant to Sections 17 (Disclosure harmful to personal privacy) and 19 (Confidential evaluations) of the *Freedom of Information and Protection of Privacy Act.*

# HIGHLIGHTS

- On 2021 December 20, Council directed the the Subdivision and Development Appeal Board ("the Board") to conduct an interview process from a pool of four candidates and to recommend one for appointment as a public member to the Board.
- This report provides Council with a recommended candidate from among the four candidates for appointment as a public member to the remaining vacancy on the Board.
- What does this mean to Calgarians? Public representation on Boards, Commissions and Committees brings specific skills and expertise that contribute to good governance, represent stakeholder groups, provide a variety of perspectives, and reflect the diversity of the community.
- Appointing a public member to fill the Board's vacancy ensures the Board has the appropriate membership to hear appeals and render appeal decisions in a timely manner and in accordance with its mandate.
- Strategic Alignment to Council's Citizen Priorities: A well-run city

### DISCUSSION

On 2021 November 09, the short list to fill the public member vacancies provided by the Chair of the Board was considered by the Nominations Committee. The Nominations Committee recommended 15 of the short-listed applicants for appointment and identified a pool of four candidates from the 2021 recruitment campaign to be considered by the Board for the remaining vacancy.

On 2021 December 20, in accordance with Council policy CP2016-03, *Governance and Appointments to Boards, Commissions and Committees,* Council directed the Board to conduct interviews with the four candidates in the recommended pool and to recommend one for appointment as a public member to the Board. The Board Chair along with both Vice-Chairs conducted interviews and recommends the candidate listed in Attachment 1.
