

Councillor Stevenson,

We the residents within the vicinity of 133 Panatella Square NW, the subject property, would like to express our concerns with the upcoming application to rezone this parcel from Special Purpose Future Urban Development (S-FUD) to Residential One/Two Dwelling (R-2) with the intended use as a Place of Worship - Small. After speaking with representatives from The Redeemed Christian Church of God, the property owners, the proposed development will pave any existing greenery and replace it with a parking lot. Furthermore, the structure will be renovated to include a chapel or place of worship on the main floor and rooms for other activities in the basement.

Some of our major concerns with the rezoning of the subject property from S-FUD to R-2 with the intended use as a Place of Worship - Small are the following:

- Failure to provide adequate stakeholder engagement in order to obtain the opinions and understanding from the surrounding community.
- Negative impact to property and resale values in the direct surrounding area.
- Increase in overall community congestion from both vehicular and human traffic.
- Parking congestion resulting from overflow from the subject property.
- Increase in noise levels from traffic, large events and congregation, and potential construction and future expansion.
- Access issues to the subject property which would result in the surrounding residential streets being inundated with an increase in traffic.
- Extremely low usage of the intended Place of Worship - Small from the surrounding community.

Attached to this letter please find a list of signatures and names from residents of the surrounding homes to the subject property. We will be attending the public hearing on October 5, 2015 and will be speaking to the above concerns as well as any other issues that may arise.










