



Background

In 1994, Council passed the Agricultural Pests Bylaw to allow for the appointment of a committee of Council to hear and determine appeals of enforcement actions taken under the Agricultural Pests Act ("the Act"). Various amendments to the Bylaw were made over the years to vary the process for establishing the authority and delegations to appoint inspectors empowered to enforce the Act, but the governance of the appeal process and committee have remained unchanged since that time.

Through One Calgary 2019-2022 Service Plans and Budgets, Council directed Calgary Community Standards to revise the Responsible Pet Ownership Bylaw to bring insightful change based on engagement of pet owners and neighbours, in a way that was reflective of current trends and improves satisfaction. Stakeholders generally supported the use of a tribunal to resolve disputes of decisions made by City Administration under the new Responsible Pet Ownership Bylaw. The mandate of the Licence and Community Standards Appeal Board (LCSAB) was therefore expanded so that it could hear and decide appeals of decisions made under the Responsible Pet Ownership Bylaw.

Previous Council Direction

On 1994 April 11, Council passed Bylaw 5M94, the Agricultural Pests Bylaw to establish a committee of Council to hear appeals of enforcement decisions made under the Act. On 1996 May 27, 1999 October 4, and 2004 November 22, Council passed subsequent amendments to Bylaw 5M94 to vary the authority and delegations for appointing inspectors empowered to enforce the Act on behalf of The City.

Through its consideration and adoption of One Calgary 2019-2022 Service Plans and Budgets, Council directed Administration to revise the Responsible Pet Ownership Bylaw to bring insightful change based on pet owners and neighbour engagement, to reflect current trends and improve satisfaction.

At its 2021 May 31 Combined Meeting, Council passed a new Responsible Pet Ownership Bylaw, Bylaw 47M2021. Through a Motion Arising, Council also directed Administration to engage the dog walking industry and return with related amendments to the Bylaw no later than 2021 Q4. Council also passed further amendments to the LCSAB Bylaw, Bylaw 50M2011 as amended, to empower the LCSAB to hear and decide appeals of decisions made by City Administration under the Responsible Pet Ownership Bylaw.

On 2021 December 20, Council passed amendments to Responsible Pet Ownership Bylaw 47M2021 to establish permits for qualified professional dog walkers to walk more than six dogs off-leash at a time. Council also directed, through a Motion Arising, that Administration develop specific criteria under which a Dogwalker Permit would be granted in consultation with business owners through the Business Advisory Committee.

At its 2021 December 20 Combined Meeting, Council considered report CD2021-1664 and amended the Responsible Pet Ownership Bylaw to allow qualified professional dog walkers with an appropriate permit to walk more than six dogs off-leash at a time. The report indicated that "proposed changes to Bylaw 50M2011 to accommodate [appeals respecting permits] will be presented to [the Community Development Committee] and Council in 2022 Q1."
