EXECUTIVE SUMMARY

This application is for an Administration initiated amendment to the Southeast Industrial Area Structure Plan to remove the 400 metre setback from the decommissioned Phosphogypsum Stack 1.

While operational, the Phosphgypsum Stack prohibited development of schools, hospitals, child care facilities, special care facilities or dwellings within the 400 metre setback area. As the stack has been decommissioned, the opportunity for the aforementioned uses should be allowed.

This ASP amendment was initiated by Administration as a result of an application for a child care facility within the existing setback.

Additionally, all references to Western Co-operative Fertilizers Limited (Viterra Inc) have been removed to reduce the potential for future amendments due to the company changing names.





PLANNING EVALUATION

SITE CONTEXT

The Southeast Industrial Area Structure Plan (ASP) covers a land area of approximately 3,763 hectares (9,299 acres) in size, comprising primarily of industrial uses, with limited commercial uses. The Plan Area is bounded by Peigan Trail SE to the north, Deerfoot Trail SE to the west, Deerfoot Trail SE and 130 Avenue SE to the south and Stoney Trail SE to the east.

The decommissioned phosphogypsum stack site is located at 11111 Barlow Trail SE, northeast of the intersection of 144 Avenue SE and Barlow Trail SE. The stack site is approximately 5.4 hectares (13.4 acres) in size.

LAND USE DISTRICTS

No land use redesignations are required as a result of this Area Structure Plan amendment.

LEGISLATION & POLICY

Southeast Industrial Area Structure Plan (1996). The current policy of the Southeast Industrial Area Structure Plan identifies a setback within 400 metres of the Western Co-Operative Fertilizers Limited (WCFL) site. The proposed amendments to remove reference of the setback on stack 1 and remove all named references of Western Co-Operative Fertilizers Limited is supported by Administration.

TRANSPORTATION NETWORKS

Transportation networks in the ASP are not affected by the proposed amendments.

UTILITIES & SERVICING

Utilities and servicing are not affected by the proposed amendments.

ENVIRONMENTAL ISSUES

Phosphogypsum Stack 1 has been decommissioned and signed off by the Government of Alberta, therefore the 400 metre setback can be removed.

This change to the separation distance applies specifically to the northeast part of the Douglas Glen residential area located west of 24 Street SE. 

Revised Map 2 - Land Use and Transportation Plan



Revised Map 3 - Regional Road Network



Revised Map 4 - Dangerous Goods and Truck Routes



Revised Map 5 - Water Supply



Revised Map 6 - Sanitary Sewer System



Revised Map 7 - Storm Sewer System



Revised Map 8 - Electrical Service



Revised Map 9 - Natural Gas



Revised Map 10 - Telephone and Cable Services



Revised Map 11 – Natural Features



Revised Map 12 – Landowners Ownership (Major Land Owners)



Revised Map 13 – Existing Land Use



Revised Map 14 - Policy Context


