Laura and I have been living at 25 Kirby Place for 4 years. And have recently decided to construct a legal secondary suite in our un-used basement. The suite would be fully self-contained within the existing structure meaning no external additions or installation would be required. We plan on living in the residence while renting out the second suite.

As part of the legal secondary suite process we are required to apply for a land use redesignation for our property. This re-designation would be from the current RC-1 (allowing for a single family dwelling) to an RC-1s (allowing for a contextual secondary suite). Before council makes a decision on our re-designation application, they look for feedback from our councilor, community association and neighbors. Part of the process will involve the city posting a re-designation notice on our property before the redesignation goes to council for approval. I would like to take this opportunity to get feedback from neighbors around our home prior to that point so we can address any comments or concerns ahead of time. Note that this process only changes the land designation allowing for a possible suite, there will be a separate process (development and building permit) that will be required prior to developing the suite.
