### **BYLAW NUMBER 46P2021**

## BEING A BYLAW OF THE CITY OF CALGARY TO AMEND THE LAND USE BYLAW 1P2007 (C2021-1082)

WHEREAS it is desirable to amend the Land Use Bylaw 1P2007, as amended;

**AND WHEREAS** Council has held a public hearing as required by Section 692 of the *Municipal Government Act*, R.S.A. 2000, c.M-26, as amended:

# NOW, THEREFORE, THE COUNCIL OF THE CITY OF CALGARY ENACTS AS FOLLOWS:

- 1. The City of Calgary Land Use Bylaw, being Bylaw 1P2007 of the City of Calgary, as amended, is hereby further amended as follows:
  - (a) Delete section 206.1 in its entirety and replace with:

### "206.1 Home Based Child Care - Class 1

- (a) means:
  - (i) an incidental *use* by a resident of a **Dwelling Unit** for the purpose of providing temporary care or supervision to a maximum of 6 children:
    - (A) under the age of 13 years, or children of 13 or 14 years of age who, because of a special need, require child care; and
    - (B) for periods of less than 24 consecutive hours;
  - (ii) a use that may have a maximum of one non-resident employee at any one time working at the residence where the use is located;
- (b) is a use within the Subordinate Use Group in <u>Schedule A</u> to this Bylaw:
- (c) must not be located in a **Dwelling Unit** containing another **Home Based Child Care Class 1** or **Home Occupation Class 2**;
- (c.1) must not display any **signs** related to the **use** on the **parcel**;
- (d) must have **screening** for any outdoor play areas:
- (e) does not require additional *motor vehicle parking stalls*; and
- (f) does not require **bicycle parking stalls class 1** or **class 2**."

- (b) Delete subsections 637(1)(f), 648(1)(f), 659(1)(f),670(1)(f), 680(1)(f) and 969(f).
- (c) Insert new subsection 637(1)(g.1) as follows:
  - "637(1)(g.1) Health Care Service;"
- (d) Insert subsection 648(1)(h.1) as follows:
  - "648(1)(h.1) Health Care Service;"
- (e) Insert subsection 659(1)(h.1) as follows:
  - "659(1)(h.1) Health Care Service;"
- (f) Insert new subsection 670(1)(g.1) as follows:
  - "670(1)(g.1) Health Care Service;"
- (g) Insert subsection 680(1)(g.1) as follows:
  - "680(1)(g.1) Health Care Service;"
- (h) Insert subsection 938(2)(o.1) as follows:
  - "938(2)(0.1) Restaurant: Food Service Only;"
- (i) Insert subsection 969(j.1) as follows:
  - "969(j.1) Health Care Service;"
- (j) Insert a new subsection 1043(2)(d.1) as follows:
  - "1043(2)(d.1) Health Care Service;"
- (k) Insert a new subsection 1279(c.1) as follows:
  - "1279(c.1) Health Care Service;"
- (I) Delete subsection 1279(2).
- (m) Delete subsection 1281.1 and replace with:

#### "Use Area

- The maximum *use area* for a **Health Care Service** located on the ground floor of a *building* is 200.0 square metres, unless the *use* activities are limited to counselling, in which case the maximum *use area* is 465.0 square metres.
  - (2) The maximum *public area* for a **Restaurant: Food Service Only** or **Restaurant: Licensed** is 150.0 square metres."
