1. November 29, 2021 - Contacted Councillor's Office
2. November 29, 2021 - Contacted Community Association
3. December 10, 2021 - Post card drop to residences in a 60m radius of subject lot

At this point we have received no feedback from the Community Association or the Councillor's Office but we did receive one online submission through our website from a nearby resident. The concerns raised were as follows:

1. Poor quality of nearby R-CG developments
2. Added density will have a negative impact on the community.
