Policy Amendment and Land Use Amendment in Montgomery (Ward 7) at 5239 – 22 Avenue NW, LOC2021-0209

RECOMMENDATIONS:

That Calgary Planning Commission recommend that Council:

- 1. Give three readings to the proposed bylaw for the amendments to the Montgomery Area Redevelopment Plan (Attachment 2); and
- Give three readings to the proposed bylaw for the redesignation of 0.06 hectares ± (0.15 acres) located at 5239 22 Avenue NW, (Plan 4994GI, Block 51, Lot 8) from Residential Contextual One Dwelling (R-C1) District to Residential Contextual One / Two Dwelling (R-C2) District.

RECOMMENDATIONS OF THE CALGARY PLANNING COMMISSION, 2022 MARCH 24:

That Council:

- 1. Give three readings to **Proposed Bylaw 26P2022** for the amendments to the Montgomery Area Redevelopment Plan (Attachment 2); and
- Give three readings to Proposed Bylaw 69D2022 for the redesignation of 0.06 hectares ± (0.15 acres) located at 5239 22 Avenue NW, (Plan 4994GI, Block 51, Lot 8) from Residential Contextual One Dwelling (R-C1) District to Residential Contextual One / Two Dwelling (R-C2) District.

HIGHLIGHTS

- The proposed application would allow for semi-detached and duplex dwellings in addition to the building types already allowed (e.g. single detached dwellings and secondary suites).
- This application represents an appropriate low-density increase of a residential site, allows for development compatible with the character of the existing neighbourhood, and aligns with the applicable policies of the *Municipal Development Plan* (MDP).
- What does this mean to Calgarians? The proposed Residential Contextual One / Two (R-C2) District would allow for greater housing choice within the community, and more efficient use of existing infrastructure and nearby amenities.
- Why does this matter? The proposal would accommodate the evolving needs of different age groups, lifestyles, and demographics.
- Amendments to the *Montgomery Area Redevelopment Plan* (ARP) are required to accommodate the proposed land use.

- No development permit application has been submitted at this time.
- There is no previous Council direction related to this proposal.
- Strategic Alignment to Council's Citizen Priorities: A city of safe and inspiring neighbourhoods.

DISCUSSION

This application, in the northwest community of Montgomery, was submitted by FarMor Architecture on behalf of the landowner, Sultan A. Makhani, on 2021 December 07. No development permit has been submitted at this time; however as noted in the Applicant Submission (Attachment 3), the applicant identified the intent to develop two dwelling units in the future with the possibility of two basement suites.

A detailed planning evaluation of the application, including location maps and site context, is provided in Attachment 1, Background and Planning Evaluation.

Applicant-Led Outreach

As part of the review of the proposed land use amendment application, the applicant was encouraged to use the <u>Applicant Outreach Toolkit</u> to asses which level of outreach with public stakeholders and the respective community association was appropriate. In response, the applicant emailed the Montgomery Community Association, and sent letters to adjacent landowners. The Applicant Outreach Summary can be found in Attachment 4.

City-Led Outreach

In keeping with Administration's practices, this application was circulated to stakeholders, notice posted on-site, published online, and notification letters were sent to adjacent landowners.

Administration received two letters of opposition from the public. The letters of opposition state concerns that the proposed redesignation will negatively impact the views and property values of neighbouring properties, and negatively impact the character of the neighbourhood.

The Montgomery Community Association did not provide a letter in response to the circulation package for this application. Administration contacted the community association to follow up, and no additional response was received.

Administration considered the relevant planning issues specific to the application and has determined the proposal to be appropriate. Minor amendments to the *Montgomery ARP* are required to support the proposal. The amendment is deemed acceptable as it is consistent with the policies of the MDP regarding modest intensification of existing neighbourhoods. The proposal is for a low density residential district compatible with the existing character of the neighbourhood. The building and site design, as well as on-site parking will be reviewed and determined at the development permit stage.

Following Calgary Planning Commission, notification for Public Hearing of Council for the land use amendment/policy amendment application will be posted on-site and mailed to adjacent landowners. In addition, Commission's recommendation and the date of the Public Hearing will be advertised.

IMPLICATIONS

Social

The proposed land use would allow for the development of two single detached homes with a subdivision, or a semi-detached or duplex dwelling. This would allow for a wider range of housing types than the existing R-C1 District and may better accommodate the housing needs of different age groups, lifestyles, and demographics.

Environmental

This application does not include any actions that specifically address the objectives of the <u>Climate Resilience Strategy</u>. Further opportunities to align future development on this site with applicable climate resilience strategies will be explored and encouraged at subsequent development approval stages.

Economic

The ability to develop up to two dwelling units would make more efficient use of existing infrastructure and services.

Service and Financial Implications

No anticipated financial impact.

RISK

There are no known risks associated with this proposal.
