Rangeview West is located in the new community of Rangeview at this time there are only a handful of residents living in range view as the first phase of development was launched in Fall 2021 by Section23 at the east end of Rangeview, near 88 ST.

During the circulation process our team reached out to Copperfield-Mahogany Community Association as listed below and maintained communication with the developer representatives of adjacent developments.

As part of the applicant preparation the Danube team reached out to Copperfield-Mahogany Community Association (CM CA) and adjacent landowner / developers to ensure the proposal is in alignment with the approved plans. The list of landowners / developers is provided below under stakeholders.

- May 27, 2021 as per city requirements Danube installed two large sign postings along 52nd St the City File Manager received one letter from an adjacent resident with questions about the wetland at the north end. The File Manager forwarded the letter to the Parks Department.
- 2. July 5, 2021 Email message to CM CA a followed by a phone call but no response was received.
- 3 Ongoing communication with representatives of Brookfield, Genstar, Hopewell and Section23 through the application preparation and circulation process.
- 4. In addition, in keeping with the City's circulation protocol the application was circulated to the Federation of Calgary Communities no comments were received.

The Rangeview West proposal is consistent with the policy direction approved in the Rangeview Area Structure Plan. The proposal aligns with the adjacent approved plans in terms of road network and land use interface.

The Danube team received a comment from Genstar Development relative to road connection issue and it has worked out a solution to the satisfaction of both developers. Through the DTR comment resolution process, the team has ensured alignment with adjacent development to along the West along 52 ST.

At this time the Danube team is not aware of any other stakeholder issues associated with the proposal
