

Continued to successfully hold virtual hearings throughout 2021

Able to provide written decisions to appeals in a record breaking 16 days post hearing conclusion

Various feedbacks from the public that decisions are clear, understandable and concise

Decisions turn-around is greatly appreciated by the public

Experienced a few technical difficulties but did not receive any public complaints about the delivery format

Numbers of decisions are appealed to the Alberta Court of Appeal in 2021 but none were granted leave by the court
