

RE: SENIORS AGE-FRIENDLY STRATEGY

In response to a growing need for specialization in the response to elder abuse, the Elder Abuse Response Team was formed in 2011 as a collaboration between Carya, the Kerby Centre, and the Calgary Police Service. The goal of the Team is to reduce the victimization of older adults by providing a multidisciplinary continuum of services and supports through identifying and assessing older adults at risk of abuse, formulating an intervention plan that may involve legal, social, and health systems, referring older adults to services in the community, conducting criminal investigations, and engaging in case management.

It is the experience of the Calgary Police Service that issues such as access to information and services, community support and health, isolation, housing, and transportation and mobility are all interlinked factors affecting the risk and seriousness of elder abuse. These issues are beyond the expertise of the Elder Abuse Response Team, and a strong coordinated community response is required in order to increase awareness, prevent, and respond to elder abuse.

By taking on a much needed leadership role in the development in this strategy, Community & Neighbourhood Services will be able to coordinate the efforts of numerous community and agency stakeholders towards a common vision of creating a more age-friendly Calgary which we believe will increase public safety and community well-being. The Calgary Police Service fully recognizes the value and necessity of a coordinated strategy, and strongly supports this initiative.
