# Overview

- Municipal Affairs is conducting consultation on specific aspects of the LAEA and Code of Conduct
- Election reform was identified as a Council priority
- Due to Municipal Affairs on July 11
- Municipal Affairs may use feedback received from municipalities to inform further consultation on “local elections and councillor accountability” this summer

# Process

Discussion at IGA on June 15. Committee expressed concern over:

- Narrow scope of questions
- Short time frame to respond
- Other topics that should also be addressed

Draft letter to Minister expressing these concerns

- More time
- Broader scope
