"West District" has been proposed for use as a street name in the community of West Springs. The name is requested for a proposed development within the community (LOC2014-0008).

REASONS FOR RECOMMENDATION:

The applicant, on behalf of the developer, has requested the street name "West District" for use in a proposed development in the West Springs community. Justification for the street name is in a letter from Civicworks (APPENDIX I).

The proposed street name was circulated and did not receive support for the following reasons:

- The word "District" in the street name could lead to confusion as district is generally used in conjunction with a community or a geographic area.
- "District" does not fit with standard naming conventions.
- Streets are not typically named for marketing purposes.
- The name does not conform with the Municipal Naming Policy criteria.

Based on the lack of support, it is recommended that West District <u>not</u> be approved as a street name.

Reasons for Opposition from Mr Friesen:

- I agreed with administration that this name would be confusing and had little to do with the location. I understand the name is not even being used for a street in the west part of West Springs.
- Names are not purely marketing tools. The notion that names should be related to their location is a sound one. In most cases meaning should take precedence over marketing.
- I support the use of historic and/or geographic names and am not convinced that it is difficult to find new names. Hire a historian or read a book. With a young city like Calgary we have little enough history and it should all be utilized. A rich cultural experience is developed by successive layers of history, not by burying what we have.
- The naming policy has a number of flaws, for example names should be unique and the use of the same name with many suffixes is very disorienting. The reintroduction of some numbered streets and avenues would be most welcome. I support the revision of the naming policy and review of the committees that develop names.
