EXECUTIVE SUMMARY

This report is for a proposed community name and street names for future development in the northern portion of Calgary. The lands are located within Community "A" of the Keystone Hills Area Structure Plan.

The proposed community name is Carrington and the proposed street names are: Carrington, Carringsby and Carringvue. Administration is recommending refusal, as the community name does not conform to the Municipal Naming Policy criteria of heritage, historical or geographical significance to Calgary. Also, Carringvue has the potential to be spelled incorrectly, which may present issues with way finding, mail delivery, etc.







APPENDIX III

APPLICANT'S SUBMISSION

Please accept this letter as the formal application for the proposed Community name of "Carrington", together with related street names to be applied within this community on land owned by Genstar Development Company ("Genstar"), The Hong Family ("Hong") and Mattamy Homes Limited ("Mattamy").

The name "Carrington" is intended to be applied to Community 'A' as identified within the Keystone Hills Area Structure Plan. Community 'A' currently contains lands owned by Genstar, Hong and Mattamy, as well as Brookfield Residential.

It is submitted that the proposed name "Carrington" is consistent with the City's community naming policy.

The investigation into the name has concluded that the first part of the name of "Caring" is derived from the tending or herding of animals in a pastoral setting (Old English). The "tending or herding" can be related back to the pioneering of the Beddington Valley in the late 1800s/early 1900s, and the cattle ranching that occurred in the area.

The suffix "ton" in the name Carrington has the direct translation to "town" or settlement (Old English), and is a common suffix used for community names.

Hence the translation of Carrington to mean "herding settlement" which is reflective of the early ranching activities characteristic of this area, and the Calgary region in general.

It is noted that the name Carrington is similar in structure, to the name Livingston, which is being proposed for Community 'B' in Keystone Hills. These two names establish a consistent approach for the Keystone Hills area that is both identifiable and unique.

The name Carrington does not appear to be similar to other community names in the City, and should not create confusion for the general public or emergency services in the City.
