1. OPENING PRAYER

Mayor Nenshi gave the opening prayer at today's Meeting.

INTRODUCTION

Councillor Pincott introduced a group of 100 grade six students from Connect Charter School, in attendance in the public gallery and accompanied by their teacher, Jody Pereverzoff and volunteer tour guides, Clare Goetz, Marie Nelson, Shelagh Morrison and Cheryl Peters.

2. PRESENTATION(S) AND RECOGNITION(S)

RECOGNITION OF CALGARY POLICE CHIEF RICK HANSON

Mayor Nenshi recognized Calgary Police Chief Rick Hanson who is retiring on 2015 March 13, after 40 years of active duty in the Calgary Police Service; with the last seven and one-half years serving as the Police Chief.

Mayor Nenshi highlighted a few of Chief Hanson's career highlights; Planning and Operations for the World Petroleum Conference in 2000 and Security Planning and Operations for the G8 Summit in 2002. The Mayor said that during Chief Hanson's tenure he championed a new approach to law enforcement: a pro-active, community-based focus on early intervention and crime prevention. Chief Hanson's priority was to address crime at its root causes and this is illustrated by the formation of three significant Youth Groups that continue to operate successfully today; Youth at Risk Development (YARD), Start Smart, Stay Safe and the Multi-Agency School Support Team.

The Mayor advised that Chief Hanson began building a permanent infrastructure to counter gang activity through the expansion of intelligence gathering and analytical capacity. He secured funding for the Guns and Gangs Unit, Gang Suppression Team and The Real-Time Operations Centre.

Mayor Venshi said that Chief Hanson will be remembered for his leadership and respect by over 2000 officers under his command, the decrease in the crime rate and his contribution to a 97% citizen satisfaction rate with policing services.

On behalf of Members of Council and the 1.2 million citizens of Calgary the Mayor congratulated Chief Rick Hanson on his impressive 40 year career and thanked him for his service.

Chief Hanson thanked Members of Council, the citizens of Calgary and the more than 2000 Calgary Police Officers for their tremendous contributions to the Calgary Police Service.

2014 CITY OF CALGARY EMPLOYEES' UNITED WAY CAMPAIGN

Mayor Nenshi recognized the tremendous success of the 2014 City of Calgary United Way Employee Campaign and invited the Executive Sponsor of the Campaign, Rob Pritchard, General Manager, Utilities and Environmental Protection to come forward for the cheque presentation.

General Manager Pritchard advised that the 2014 City of Calgary United Way Employee Campaign demonstrated the incredible generosity of City employees. He indicated that the theme for this year was "United. Building a great city for everyone" and that the 2014 donation of \$462,000 is proof that employees truly did unite and take meaningful action by pledging, participating in corporate and business unit events and volunteering their time. The Campaign was recognized by the United Way by the presentation of two Spirit of Gold Awards; Outstanding Workplace Campaign in the Public Sector and for Diversity.

General Manager Pritchard acknowledged and extended special thanks to the following individuals: Kyle Riva, Campaign Lead, Kyle Daem, Flower Day Coordinator, the 47 Employee Campaign Coordinators, the Administrative Leadership Team, Members of Council and City Employees who contributed and supported the United Way.

Dr. Lucy Miller, President and Chief Executive Officer of the United Way of Calgary and Area came forward to receive the cheque presented by Mayor Nenshi and Rob Pritchard. Dr. Miller expressed her appreciation to the employees of The City of Calgary for their support and leadership in helping to create a great City for everyone. She congratulated The City on a record year for the Campaign as well as for receiving two Spirit of Gold Awards.

Mayor Nenshi, on behalf of Members of Council, thanked General Manager Rob Pritchard and his colleagues at The City of Calgary for making a difference in the 2014 United Way campaign.

IN MEMÒRY

Mayor Nenshi acknowledged the passing of Jacqueline Battistella on 2015 March 01. He advised that Ms. Battistella was a pioneer in building The City and that her legacy lives on throughout the community.

3. <u>QUESTION PERIOD</u>

(1) Recognition of Philanthropist (Councillor Magliocca)

In recognition of a prominent corporation in Calgary who has donated over \$48 million dollars to various charities and who has a 35 year anniversary this year, I am wondering if it is appropriate to acknowledge Shane Homes with a plaque from The City?

Jeff Fielding, City Manager, responded that he would take the request under advisement.

(2) Illegal Dumping within The City (Councillor Chabot)

I have received complaints from residents in my Ward regarding illegal dumping occurring on roadways in the community. Can you advise if this is occurring throughout The City, the cost to mitigate and what is being done about it?

Mac Logan, General Manager, Transportation, responded that The City has dedicated \$1.37 million per year to debris and animal pickup. He indicated that crews are on standby so when they receive a 311 call they are deployed immediately to pick up the discarded item and take it to the landfill. General Manager Logan advised the crews do approximately 20 pickups per day of discarded items such as couches, mattresses, refrigerators, etc. from not only the main roadways, but also from back alleys. The General Manager said the other program relating to this inquiry is the refuse pickups in the downtown core which cost approximately \$1700 per day.

General Manager Logan advised that the problem of illegal dumping is not predominant to only one area in The City. He further elaborated on the fines; \$500 for littering; \$500 for dumping on a roadway and \$750 for throwing litter out of a vehicle. The General Manager advised there is a tremendous opportunity with the 311 system and the mobile app, where that citizens can take photos of illegal dumping activities and licence plate numbers if possible, and send them in to help enforcement. (3) Two Significant Fires (Councillor Woolley)

Recently there were two significant fires in Calgary; one in Victoria Park and one in Mission. Tragically a client at the Alpha House in Victoria Park lost his life in that fire. Could I receive an update on the work of the Calgary Fire Department in these two situations?

Stuart Dalgleish, General Manager, Community Services and Protective Services, advised that both fires occurred on Saturday, 2015 March 07. He advised that the call came in after midnight for the fire at the Alpha House and the Calgary Fire Department was able to extinguish it very quickly, with fire crews off the scene by 3:00 a.m. Unfortunately there was a death at this fire and an investigation is ongoing at this time.

General Manager Dalgleish advised that with the second fire at the four-storey apartment building under construction in Mission, the call came in just before noon. The fire developed very quickly and the Calgary Fire Department's approach was very much a defensive one, with containment managed by 1:30 p.m. An investigation of this fire is also underway and will hopefully be concluded soon. General Manager Dalgleish indicated that with safety concerns around the site, the south lanes of 17th Avenue, as well as the east and west bound lanes have not been opened. He recognized the extremely prompt and effective management of both these fires by the Calgary Fire Department.
