

**Street Name in Silverado (Ward 13), SN2022-0003**

**RECOMMENDATION:**

That Calgary Planning Commission recommend that Council:

Adopt, by resolution, the proposed street name: Silver Spruce.

**RECOMMENDATION OF THE CALGARY PLANNING COMMISSION, 2022 JULY 21:**

That Council adopt, by resolution, the proposed street name: Silver Spruce.

**HIGHLIGHTS**

- This application proposes a new street name, Silver Spruce, for use in the community of Silverado.
- Administration recommends approval of the proposal as it complies with the *Municipal Naming, Sponsorship and Naming Rights Policy*, and the *Southwest Community 'A' and Employment Centre/ Mixed-Use Area Structure Plan*.
- What does this mean to Calgarians? Municipal naming of communities and streets plays an important role in simple and unambiguous identification for location and navigation within Calgary.
- Why does this matter? The proposal will assist citizens and emergency services operators in navigating to and within the developing community of Silverado by allowing for unique street names for the north portion of the community.
- The application is associated with land use and outline plan application LOC2021-0152.
- There is no previous Council direction regarding this proposal.
- Strategic Alignment to Council's Citizen Priorities: A city of safe and inspiring neighbourhoods.

**DISCUSSION**

This application, located in the southwest community of Silverado, was submitted by B&A Planning Group on behalf of the developer, Apex Limited Partnership, on 2022 April 28. The subject land is located south of Stoney Trail SW between Spruce Meadows Way SW and Sheriff King Street SW.

Location maps and site context, is provided in Attachment 1.

The proposed street name, Silver Spruce, was selected by the developer to complement the existing community and reflect the heritage of subject site, which was previously owned by Spruce Meadows. More information can be found in the Applicant Submission in Attachment 2.
