At the time of the last report to City Council on December 8, 2014, our client supported the recommendation to table the item to the 2015 March public hearing date.

We appreciate that having only recently met with you both on January 21st to discuss "community benefit" concepts that might both improve the proposed project and the adjacent residential precinct, that there may not be sufficient time to revisit those original design drawings or to have a collaborative meeting with the Community Association representatives in advance of the March public hearing.
