- ii. Give three readings to the proposed Bylaw for amendments to the Eau Claire Area Redevelopment Plan (Attachment 4).





## Why We Are Here

New Plus 15 Policy adopted by Council in 2021 July

Plus 15 Policy has expanded the Plus 15 Network into Eau Claire

Implementation of this Plus 15 Policy requires housekeeping amendments to affected Local Area Plans and the Land Use Bylaw

Changes to address clarity in the protocols

### Ipdates to CR20 District (Bonus Density Rules)

Update rules to align with new Energy Code

Update all relevant rules with updated defined terms

Amend definition of City Manager






### **Amendments to Eau Claire ARP**

- Recognize expansion of Plus 15 Network into Eau Claire (Greenline 2 Street SW LRT Station)
- Policies to guide design of Plus 15 Bridges to have consideration for landmark view (Chinese Cultural Centre)
- Policies to direct Plus 15 Network expansion to optimize connections to future Greenline Station (2 Street SW)



## Plus 15 Boundary - Considerations



- Extended Plus 15 boundary partially into Chinatown
- Extended north to capture the future Green Line LRT station
- During engagement (2018 & 2019), we heard that there was a desire to connect Chinatown into the Plus 15 Network
  - Took a balanced approach
  - Plus 15 network geared to mostly office, commercial uses
