Policy Amendment and Land Use Amendment in Montgomery (Ward 7) at 5112 – 21 Avenue NW, LOC2022-0066

RECOMMENDATIONS:

That Calgary Planning Commission recommend that Council:

- 1. Give three readings to the proposed bylaw for the amendments to the Montgomery Area Redevelopment Plan (Attachment 2); and
- Give three readings to the proposed bylaw for the redesignation of 0.06 hectares ± (0.14 acres ±) located at 5112 21 Avenue NW (Plan 4994GI, Block 50, Lot 9) from Residential Contextual One Dwelling (R-C1) District to Residential Contextual One / Two Dwelling (R-C2) District.

RECOMMENDATIONS OF THE CALGARY PLANNING COMMISSION, 2022 JULY 21:

That Council:

- 1. Give three readings to **Proposed Bylaw 48P2022** for the amendments to the Montgomery Area Redevelopment Plan (Attachment 2); and
- Give three readings to Proposed Bylaw 132D2022 for the redesignation of 0.06 hectares ± (0.14 acres ±) located at 5112 21 Avenue NW (Plan 4994GI, Block 50, Lot 9) from Residential Contextual One Dwelling (R-C1) District to Residential Contextual One / Two Dwelling (R-C2) District.

HIGHLIGHTS

- The proposed land use amendment would allow for semi-detached dwellings and duplex dwellings in addition to the building types already allowed (e.g. single detached dwellings and secondary suites).
- This application represents an appropriate density increase of a residential site, allows for development compatible with the character of the existing neighbourhood and aligns with the applicable policies of the *Municipal Development Plan* (MDP).
- What does this mean to Calgarians? The proposed Residential Contextual One / Two Dwelling (R-C2) District would allow for greater housing choice within the community and more efficient use of existing infrastructure and nearby amenities.
- Why does this matter? The proposal would accommodate the evolving housing needs of different age groups, lifestyles and demographics.
- Amendments to the *Montgomery Area Redevelopment Plan* (ARP) are required to accommodate the proposal.
- No development permit has been submitted at this time.
- There is no previous Council direction related to this proposal.
- Strategic Alignment to Council's Citizen Priorities: A city of safe and inspiring neighbourhoods

DISCUSSION

This application, in the northwest community of Montgomery, was submitted by Tricor Design Group on behalf of the landowner, HBC Custom Homes, on 2022 April 19. No development

permit has been submitted at this time; however, as noted in the Applicant Submission (Attachment 3), the applicant intends to develop a semi-detached dwelling in the future.

Applicant-Led Outreach

As part of the review of the proposed land use amendment application, the applicant was encouraged to use the <u>Applicant Outreach Toolkit</u> to assess which level of outreach with public stakeholders and the community association was appropriate. In response, the applicant contacted the Montgomery Community Association and delivered letters to adjacent landowners. The Applicant Outreach Summary can be found in Attachment 4.

City-Led Outreach

In keeping with Administration's practices, this application was circulated to stakeholders, notice posted on site and published <u>online</u>. Notification letters were sent to adjacent landowners.

Administration received eight letters of opposition from the public. Primary concerns include:

- changes to the community character;
- building height and shadowing;
- privacy considerations;
- density:
- loss of mature trees; and
- parking and traffic impacts.

No comments from the Montgomery Community Association were received through circulation. Administration contacted the Community Association to follow up but did not receive a response.

Administration considered the relevant planning issues specific to the application and has determined the proposal to be appropriate. The amendment is deemed acceptable as it is consistent with the policies of the MDP regarding modest intensification of existing neighbourhoods. The proposal is for a low-density residential district compatible with the existing character of the neighbourhood. While the building height, landscaping and parking will be reviewed at the development permit stage, the rules for R-C2 are the same as the current R-C1 District.

Following Calgary Planning Commission, notifications for a Public Hearing of Council for the land use amendment and policy amendment will be posted on site and mailed out to adjacent

landowners. In addition, Commission's recommendation and the date of the Public Hearing will be advertised.

IMPLICATIONS

Social

The proposed land use would allow for the development of either two single detached homes with a subdivision, or a semi-detached or duplex dwelling. This allows for a wider range of housing types than the existing R-C1 District and may better accommodate the housing needs of different age groups, lifestyles and demographics.

Environmental

This application does not include any actions that specifically address the objectives of the <u>Climate Resilience Strategy</u>. Further opportunities to align future development on this site with applicable climate resilience strategies will be explored and encouraged at subsequent development permit stages.

Economic

The ability to develop up to two dwelling units on site will make more efficient use of existing infrastructure and services.

Service and Financial Implications

No anticipated financial impact.

RISK

There are no known risks associated with this proposal.
