With 29% of the population in Mahogany being 0-14 years old (~ 2,050, from a City of Calgary Census), our community has **2 elementary schools** in the area Devine Mercy, which is no longer taking students (so anyone new goes to Mongsinor in Douglasdale) and the newest school which only has capcity for 600 students, wich has almost reached capacity. Using the CBE "find a school tool", it seems there's **one designated Middle school** in Sharewood and **one designated Highschoo** in Seton.

There is no talks about opening more schools or sharing designation with neighbouring communities like Auburn Bay, Seton, Cranston, New Brighton, etc for most grades. In short our kids need to go to other further communities and **we NEED** designated land for future **SCHOOLS within the Mahogany community**.
