#### **BYLAW NUMBER 8M2001**

# BEING A BYLAW OF THE CITY OF CALGARY TO ESTABLISH THE POSITION OF A CITY MANAGER

(Amended by Bylaw Number 42M2004, 47M2020, 60M2021)

**WHEREAS** the <u>Municipal Government Act</u> requires a municipality to establish a position of chief administrative officer,

# NOW, THEREFORE, THE COUNCIL OF THE CITY OF CALGARY ENACTS AS

### **FOLLOWS:**

- 1. There is hereby established the position of a chief administrative officer pursuant to section 205(1) of the *Municipal Government Act*, with all powers, duties and functions of that position given by that Act, any other enactment, or by Council.
- 2. The position established pursuant to Section 1 shall be known as the City Manager.

- 3. Council shall appoint the City Manager from time to time and the City Manager may appoint a person to act in that position in the temporary absence of the City Manager.

- 4. Without limiting the generality of Section 1, all powers, duties and functions delegated by Council to the Board of Commissioners, the four individual Commissioner and any Assistant Commissioner pursuant to former Bylaw 9017 are hereby delegated to the City Manager, who may further delegate any such power, duty or function.

5. Notwithstanding Section 4 or the repeal of Bylaw 9017, a power, duty or function which was delegated by the Board of Commissioners, Commissioner or Assistant Commissioner while acting pursuant to Bylaw 9017 is hereby ratified and continued until such delegation is altered by the City Manager.

5.1 Despite any direction or delegation contained in any other bylaw or policy to the contrary, the City Manager, or the City Manager's delegate, is authorized to investigate and implement discipline in matters involving any City of Calgary non-unionized staff in accordance with City policies, including but not limited to any non-unionized contract employees, but excluding the City Auditor and City Auditor staff.
