Pro-tem Membership Committee Recommendations for Standing Policy Committee Appointments

RECOMMENDATIONS:

That Council:

- 1. Appoint the four Councillors listed in Attachment 1 to a Pro-tem Membership Committee;
- 2. Appoint the seven Councillors recommended by the Pro-tem Membership Committee to each of the following Standing Policy Committees, for terms set to expire at the 2023 Organizational Meeting of Council:
 - a) Community Development Committee;
 - b) Infrastructure and Planning Committee; and
- 3. Direct that the closed meeting discussions and Attachment 2 remain confidential pursuant to Sections 17 (Disclosure harmful to personal privacy) and 19 (Confidential evaluations) of the Freedom of Information and Protection of Privacy Act.

HIGHLIGHTS

- The Procedure Bylaw, 35M2017, provides for the creation of a Pro-tem Membership Committee ("Pro-tem Committee") to nominate seven Councillors for appointment to Standing Policy Committees ("SPCs") for the following year.
- What does this mean to Calgarians? The appointment of Councillors to the Pro-tem Committee ensures appropriate governance and supports effective decision-making.
- Why does this matter? Effective governance and decision-making about the membership of SPCs ensures that Calgarians are well-served.
- Strategic Alignment to Council's Citizen Priorities: A well-run city

DISCUSSION

Annually, Council must appoint four Councillors to a Pro-tem Committee, whose purpose is the nomination of seven Councillors to serve on each SPC for the following year. The Mayor is an Ex-Officio Member of the Pro-tem Committee.

With the exception of a General Election year, the membership of the Pro-tem Committee includes current SPC Chairs. For the 2022 Pro-tem Committee, in addition to the two current SPC Chairs, the proposed membership includes two Councillors selected by random draw.

The Pro-tem Committee will meet during a recess of the 2022 Organizational Meeting of Council to nominate Councillors for appointment. After receiving the recommendations of the Pro-tem Committee, Council will appoint Councillors to each SPC, having regard for Councillors' preferences and the best interests of The City.
