The Multi-Year Business Planning and Budgeting Policy (CFO004) for The City of Calgary (The City) along with the Council-approved Multi-Year Service Planning and Budgeting Principles provide the policy direction and guide the decision-making process for service planning and budgeting over multiple four-year cycles. These principles are embedded in the planning process and will be incorporated into policy in the future.


