

BYLAW NUMBER 2M2015

**BEING A BYLAW OF THE CITY OF CALGARY
TO AMEND BYLAW 60M90, BEING A BYLAW
OF THE CITY OF CALGARY RESPECTING
TRUCK ROUTES**

WHEREAS Council has considered Report TT2014-0931 and considers it necessary to amend Bylaw 60M90;

NOW, THEREFORE, THE COUNCIL OF THE CITY OF CALGARY ENACTS AS FOLLOWS:

1. Bylaw 60M90, as amended, is hereby further amended.
2. In subsection 18(4), the words "One Hundred Dollars (\$100.00)" are deleted and replaced with "Five Hundred Dollars (\$500.00)".
3. In **SCHEDULE "A"**, under 1. **NUMBERED STREETS**, under the headings indicated, the following is deleted:

<u>STREET</u>	<u>FROM</u>	<u>TO</u>
"52nd Street E.	17th Avenue S.	Marquis of Lorne Trail"

and replaced with the following:

<u>STREET</u>	<u>FROM</u>	<u>TO</u>
"52nd Street E.	17th Avenue S.	Seton Boulevard"

4. In **SCHEDULE "A"**, under 3. **NAMED STREETS, AVENUES AND OTHER HIGHWAYS**, under the headings indicated, the following is deleted:

<u>HIGHWAY</u>	<u>TO</u>	<u>FROM</u>
"Metis Trail	McKnight Boulevard	Stoney Trail"

and replaced with the following:

<u>HIGHWAY</u>	<u>TO</u>	<u>FROM</u>
"Metis Trail	McKnight Boulevard	North City Limits"

5. In **SCHEDULE "A"**, under **3. NAMED STREETS, AVENUES AND OTHER HIGHWAYS**, after:

<u>HIGHWAY</u>	<u>TO</u>	<u>FROM</u>
"Sarcee Trail	Glenmore Trail	16th Avenue N. (Trans Canada Highway)"

the following is added under the headings indicated:

<u>HIGHWAY</u>	<u>TO</u>	<u>FROM</u>
"Seton Boulevard	Deerfoot Trail	52nd Street E."

6. In **SCHEDULE "A"**, under **3. NAMED STREETS, AVENUES AND OTHER HIGHWAYS**, under the headings indicated, the following is deleted:

<u>HIGHWAY</u>	<u>TO</u>	<u>FROM</u>
"Shaganappi Trail	Bowness Road	Stoney Trail"

and replaced with the following:

<u>HIGHWAY</u>	<u>TO</u>	<u>FROM</u>
"Shaganappi Trail	Bowness Road	North City Limits"
