

Recommendation

That the Infrastructure and Planning Committee recommend that Council:

1. Direct Administration to bring forward the following to the 2022 December 6 Combined Meeting of Council:
 - a) The Chinatown Cultural Plan (Attachment 2);
 - b) A Bylaw to establish the Chinatown Redevelopment Plan (Attachment 3) for First Reading, to allow for the required advertising; and
 - c) Allow for the withholding of Second and Third Readings of the Proposed Bylaw until the Chinatown Area Redevelopment Plan has been approved by the Calgary Metropolitan Region Board;
2. Approve a new name for the former James Short Park and Parkade site located at 115 4 Avenue SW; and
3. Direct that confidential Attachment 4 and Closed Meeting discussions be held confidential pursuant to Sections 23 (Local public body confidences) and 24 (Advice from officials) of the *Freedom of Information and Protection of Privacy Act*.

A. People, voices and experiences




B. Culture, creative and learning

Chinatown Area Redevelopment Plan

Chinatown's success relies on the area being a culturally distinctive place where people want to live, visit and set up business.


- Long-range, statutory plan that sets out the future vision for redevelopment in Chinatown.
- Serves to provide consistency and certainty to the community, developers and decision-makers.
- Informed by the Chinatown Cultural Plan, the document highlights the clear intersections between cultural and land use planning.



Role of the Area Redevelopment Plan

Core ideas of the ARP :

1. An affordable and attractive residential neighbourhood
2. A unique character continues to be expressed through the built environment
3. Chinatown's historic significance is preserved
4. Vibrant streets and eclectic commercial offerings support a thriving local economy
5. Chinatown supports community, family and individual health and harmony



Renaming James Short Park and Parkade

A new name is being recommended to acknowledge the racial discrimination faced by Chinese Calgarians.

Renaming civic assets is an important step towards becoming an anti-racist and inclusive city.
