# Federation of Canadian Municipalities (FCM) Update - October (Verbal) – IGA2022-1107 Intergovernmental Affairs Committee - 2022 October 12

#### Recommendation

### Recent Meetings and Events - 2022 Annual FCM Board of Directors Meeting

The 2022 Annual FCM Board of Directors Meeting was held in Strathcona County September 13-15, 2022. FCM's Board of Directors is made up of elected municipal officials and affiliate members from communities across Canada.

#### Committee of the Whole

- The Committee of the Whole focused their conversation on:
  - o RCMP retroactive pay increases.
  - o Future of Federal infrastructure programs
  - o Housing and homelessness, including encampments
  - Climate change and adaptation
- At the meeting, FCM laid out their eight key advocacy planks as follows:
  - 1. Double Canada Community Building Fund to \$4.4B a year
  - 2. Establish Permanent Public Transit Fund at \$3B per year
  - 3. Increase funding for adaptation by at least \$1B per year
  - 4. Create a new dedicated water infrastructure funding (like Clean Water and Wastewater Fund from 2016)
  - 5. Rural and Northern infrastructure (broadband, ports, and airports etc.)
  - 6. Net zero communities (municipal building retrofits, municipal fleet vehicles, landfill gas capture, community energy, Energy Community Infrastructure Fund)
  - 7. Close the Indigenous infrastructure gap and end all boil water advisories
  - 8. Downtown renewal and regional economic development (trilateral agreements, Regional Economic Development Agencies)

#### **Board of Directors Meeting**

- The Board of Directors heard from regional caucuses and each standing committee.
   Highlights include:
  - The Standing Committee on Anti-Racism and Equity Committee adopted a
     Commitment Statement at the Board of Directors Meeting, recognizing FCM's
     opportunity and responsibility to ground the organization's culture, systems,
     policies and practices in an anti-racism and equity lens. FCM Anti-Racism and
     Equity Commitment Statement

- The Board discussed the release of FCM's new National Adaptation Strategy that highlights proposals that would assist municipalities to be better protected from extreme weather. <u>National Adaptation Strategy: Recommendations from the</u> Federation of Canadian Municipalities (fcm.ca)
- All proposed resolutions passed. Resolutions were as follows:
  - o Environmental Issues and Sustainable Development
    - Federal support for Canadian consumption of Canadian oil and gas resources
    - Fossil fuel non-proliferation treaty
    - Scrubber discharge
  - o Social-Economic Development
    - Exempting income on secondary units
    - National licensure for healthcare professionals
  - Municipal Infrastructure and Transportation Policy
    - Aerodrome approvals and changes
  - Anti-Racism and Equity Committee
    - Measures to tackle Islamophobia
