Land Use Redesignation Applicant's Submission Not Including Secondary Suites

On behalf of the landowner, please accept this application to redesignate a +/-0.057 hectare site from R-C2 to R-CG to allow for:

- rowhouses in addition to the uses already allowed (e.g. single-detached, semi-detached, and duplex homes and suites)
- a maximum building height of 11 metres (an increase from the current maximum of 10 metres)
- a maximum of 4 dwelling units (an increase from the current maximum of 2 dwelling units)
- the uses listed in the proposed R-CG designation.

The subject site, 2402 41 Street SE, is a corner lot located in the community of Forest Lawn along 23 Ave and 41 Street SE. The site is approximately 0.057 hectares in size with approximate dimensions of 15.24 by 37.16 meters. A rear lane exists to the east of the site. The property is currently developed with a one-storey single detached dwelling built in the late 50s.

The closest bus stop is either along 44 Street SE roughly 320 meters away or along 26 Ave SE also about 320 meters. The site is in close distance to many commercial establishments along 48 Street or public schools along 26 Ave. Vehicle access to the parcel is available and will be via the rear lane.

Public Engagement

Before undertaking the project, our office completed the "Community Outreach Assessment". The project's impact score is "1A". So we took a direct approach to reach to community association, local residents within a 90 meters radius.

On May 18th, 2022, our staff did post card deliver to residents within a 90 meters radius. During the process, our staff did door knocking and spoke with residents at home. The main concerns our office got are with regards to increased traffic, increased density, height, shadow effects, and safety. We believe those can be properly dealt with at the development permit stage.

Policy Alignment

The subject parcel is located within the Residential-Developed-Inner City area of the Municipal Development Plan. The applicable policies encourage redevelopment of inner-city communities that is similar in scale and built form to existing development, including a mix of housing such as townhouses and row housing. The Municipal Development Plan also calls for a modest intensification of the inner city, an area serviced by existing infrastructure, public amenities and transit. The proposal is in keeping with the relevant policies of the MDP as the rules of the R-CG provide for development forms that may be sensitive to existing residential development in terms of height, built form and density.

The proposed R-CG is a Low Density Residential District. With the lot being a corner lot, the impacts of higher density use on neighbouring lower density properties can be reduced. Housing that faces both streets adds to the residential appearance of the side streets and tends to slow traffic and enhance pedestrian safety and experience on adjacent sidewalks.

We ask the city to support our application based on the reasons listed above. In addition, even though the proposed R-CG is low density district, the site also meets most of the criteria for Multi-Residential Infill including:

- within 400 meters of a transit stop
- direct lane access
- along or in close proximity to an existing or planned corridor or activity centres
- On a corner parcel
