# Street Name Change in Haskayne (Ward 1) for Morton Ridge NW, SN2022-0006

## **RECOMMENDATION:**

That Calgary Planning Commission recommend that Council:

Adopt, by resolution, the proposed street name change from Morton Ridge NW to Crimson Ridge NW.

#### **HIGHLIGHTS**

- This application proposes a street name change from Morton Ridge to Crimson Ridge in the northwest community of Haskayne.
- Administration recommends approval of the proposal as it complies with the Municipal Naming, Sponsorship and Naming Rights Policy.
- What does this mean to Calgarians? Municipal naming of communities and streets plays an important role in simple and unambiguous identification for location and navigation within Calgary.
- Why does this matter? The proposal will assist citizens and emergency services
  operators in navigating to and within the developing community of Haskayne by allowing
  for unique street names in the east portion of the community.
- There is no previous Council direction regarding this proposal.
- Strategic Alignment to Council's Citizen Priorities: A city of safe and inspiring neighbourhoods.

#### DISCUSSION

This street name change application for the northwest community of Haskayne was submitted by B&A Planning Group on behalf of the developer, Madlee Development Limited, on 2022 October 10. The subject land is located north of the Bow River, west of Twelve Mile Coulee Road NW and south of the Lynx Ridge Golf Club. Location Maps are provided in Attachment 1.

An outline plan application (LOC2018-0279) and a street naming application (SN2020-0003) for the subject area was approved by Calgary Planning Commission at the 2020 October 15 meeting. The associated land use amendment was approved at the 2020 December 14 meeting of Council.

The applicant is proposing to change the existing approved name of Morton Ridge to Crimson Ridge. The existing name Morton Ridge was named after the original landowner James Alexander Morton. As the area is still under development and the subdivision is pending registration, Morton Ridge has not yet been used for addressing purposes. The proposed name Crimson Ridge not only has ties to the Ridge itself but the 'Crimson' in the name reflects the openness, expanse and views of the sunset over the Bow Ridge valley. More information can be found in the Applicant Submission in Attachment 2.

Administration has considered the proposed name and has found that the proposal complies with the *Municipal Naming, Sponsorship and Naming Rights Policy*. Administration has considered the relevant planning issues and has determined the proposal to be appropriate.
