# Secondary Street Names in Bowness (Ward 1), SN2022-0005

- What does this mean to Calgarians? Secondary roadway names can be displayed on roadway signs in cases of historical, heritage or community value at the discretion of Council. Secondary street names are commemorative only and are not used for addressing or navigation purposes.
- Why does this matter? This proposal honours the history of Bowness by displaying street names that were used before the town was annexed into the city of Calgary. Secondary street names may help connect Calgarians to the historical nature of a community.
- There is no previous Council Direction regarding this proposal.
- Strategic Alignment to Council's Citizen Priorities: A city of safe and inspiring neighbourhoods

#### DISCUSSION

This secondary street naming application for the northwest community of Bowness was submitted by the Bowness Historical Society on 2022 June 16. The applicant is proposing secondary street names for 17 streets within the community using the historic street names from the town of Bowness prior to annexation into the city of Calgary in 1964. Location Maps are provided in Attachment 1.

All proposed street names were selected by the applicant based on a historic Town of Bowness map found in the University of Calgary archives. During the application review and circulation period, these names were verified by cross-referencing historic Town of Bowness maps found in the City of Calgary Archives. The list of proposed secondary street names is provided in Attachment 2.

Secondary names will not be used for addressing purposes and are meant to be commemorative only. The intent of this proposal is to highlight the unique history and character of Bowness, which is in alignment with the vision statement of the *Bowness Area Redevelopment Plan:* 

"To ensure all existing and new development contributes to the enhancement of Bowness as a unique community with its own small town history and spirit."

Schedule 1, Section 2.2.10 of the *Municipal Naming, Sponsorship and Naming Rights Policy*, states:

"Dual naming of roadways is not normally permitted. However, secondary names may be used on signage in cases of historical, heritage, or community value at the direction of Council."

Administration has considered the secondary names and found that the proposal complies with the *Municipal Naming, Sponsorship and Naming Rights Policy.* The full Policy Steward's Compliance Report can be found in Attachment 3.

Administration has considered the relevant planning issues and relevant public group feedback specific to the application and has determined the proposal to be appropriate.
