The safety dashboard provides information related to the following:


- Lost Time


Safety Dashboard (as of January 1, 2023)

Safety Inspections

Frequency of the BDURP site safety inspections:

Inspection By	Frequency
BDURP Contractor	Daily
GL Safety Officer	Daily
GL Site Project Manager	Daily
GL Office Management	Weekly
GL Senior Leadership	Monthly

Safety Audits

Audits are conducted against a pre-determined audit criteria:

- Say what you plan to do (COR Elements)
- Do what you said you were going to do
- Show me that you did what you said you were going to do (records)

Audits are conducted using three tools:

- Document Review (Safety Management System records)
- Interviews (management, supervisors and workers)
- Observations (in the workplace including offices and in the field)

Audits identify gaps in compliance to the safety plan which result in:

 Audit findings or opportunities for Improvement which are addressed in the resulting Safety Audit Action Plan.



Safety Audits (Cont'd)

Audit Description	External / Internal	Scope	Frequency
Certificate of Registration (COR)	External (City retained COR Consultant)	Document review, employee interviews, and observations	Every 3 years
COR Maintenance	Internal (GL Safety Officer)	Document review, employee interviews, and observations	Completed on years between external audits
Third Party Safety Professional	External	Issue focused based on observed trends	2023
Contractor Safety Performance and Compliance	Internal (City Safety Operations)	Review of contractor's safety processes, procedures, and compliance	As needed



Review Cycle

Safety Information including the Safety Dashboard, trends, and completed audits will be provided to the Green Line Board on a monthly basis.

Technical, Psychological and Public Safety
