It is the responsibility of the applicant to notify all other parties including property managers and owners, banks, Licence and Registries, and the Alberta Land Titles Office.

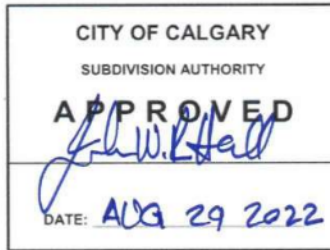
