



Purpose

This Direct Control District is intended to accommodate a Medical Clinic with reduced parking requirements on a site with limited on-site parking.

Compliance with Bylaw 1P2007

Unless otherwise specified, the rules and provisions of Parts 1, 2, 3 and 4 of Bylaw 1P2007 apply to this Direct Control District.

Reference to Bylaw 1P2007

Within this Direct Control District, a reference to a section of Bylaw 1P2007 is deemed to be 3 a reference to the section as amended from time to time.

AMENDMENT LOC2014-0007 BYLAW NUMBER 127D2014

Permitted Uses

The *permitted uses* of the Commercial-Community (C-C1) District of Bylaw 1P2007 are the *permitted uses* in this Direct Control District.

Discretionary Uses

The *discretionary uses* of the Commercial-Community (C-C1) District of Bylaw 1P2007 are the *discretionary uses* in this Direct Control District.

Bylaw 1P2007 District Rules

Unless otherwise specified, the rules of the Commercial-Community (C-C1) District of Bylaw 1P2007 apply in this Direct Control District.

Use Area

- 7 (a) The maximum *use area* for a Medical Clinic is 450 square metres.
 - (b) In all other cases, the rules of 1P2007 apply.

Required Motor Vehicle Parking Stalls

- 8 (a) A minimum of 10.0 *motor vehicle parking stalls* are required for any **Medical Clinic** if located on the main floor within the existing building.
 - (b) In all other cases, the rules of 1P2007 apply:
