## BYLAW NUMBER 66P2022

### BEING A BYLAW OF THE CITY OF CALGARY TO AMEND THE LAND USE BYLAW 1P2007 (IP2022-1045)

\*\*\*\*\*

**WHEREAS** it is desirable to amend the Land Use Bylaw 1P2007, as amended;

**AND WHEREAS** Council has held a public hearing as required by Section 692 of the Municipal Government Act, R.S.A. 2000, c.M-26, as amended:

**NOW, THEREFORE, THE COUNCIL OF THE CITY OF CALGARY ENACTS AS FOLLOWS:**

1. The City of Calgary Land Use Bylaw, being Bylaw 1P2007 of the City of Calgary, as amended, is hereby further amended as follows:
  - (a) Amend subsection 3(f) by deleting “and” after “;”.
  - (b) Amend subsection 3(g) by deleting “.” after the word “Clerk” and inserting “; and”.
  - (c) Insert a new subsection 3(h) as follows:

“**3(h)** Heritage Guideline Areas Maps deposited with the City Clerk.”
  - (d) Add a new subsection 13(73.2) as follows:

“**13(73.2)** “*heritage guideline area*” means those lands within an area indicated on the Heritage Guideline Areas Maps.”
  - (e) Amend subsection 347(1)(c)(iv) and 347(1)(d) by deleting “and” after “;” in each subsection.
  - (f) Amend subsection 347(1)(e) by deleting “.” after the word “metres” and inserting “; and”.
  - (g) Insert a new subsection 347(1)(e.1) as follows:

“**347(1)(e.1)** must not be located on a *parcel* that is within a *heritage guideline area*.”
  - (h) Amend subsection 347.1(1)(g) by deleting “and” after “;”.
  - (i) Insert a new subsection 347.1(1)(g.1) as follows:

“**347.1(1)(g.1)** must not be located on a *parcel* that is within a *heritage guideline area*; and”
  - (j) Amend subsection 347.3(1)(f)(iv) by deleting “and” after “;”.

- (k) Amend subsection 347.3(1)(g) by deleting “.” after the word “metres” and inserting “; and”.
- (l) Insert a new subsection 347.3(1)(h) as follows:  
“**347.3(1)(h)** must not be located on a *parcel* that is within a *heritage guideline area*.”
- (m) Add the maps attached as Schedule “A” as the Heritage Guideline Areas Maps, to be deposited with the City Clerk.

2. This Bylaw comes into force on December 20, 2022.

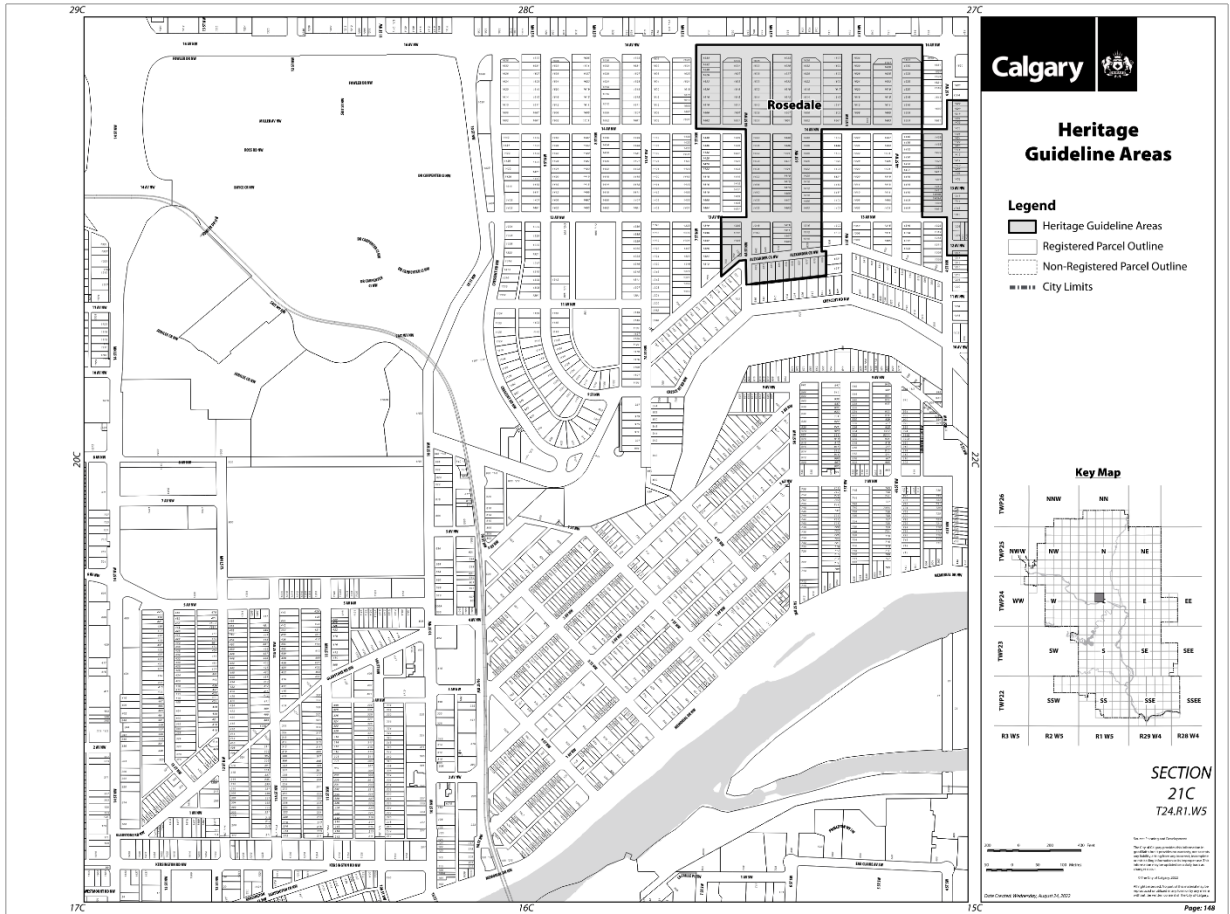

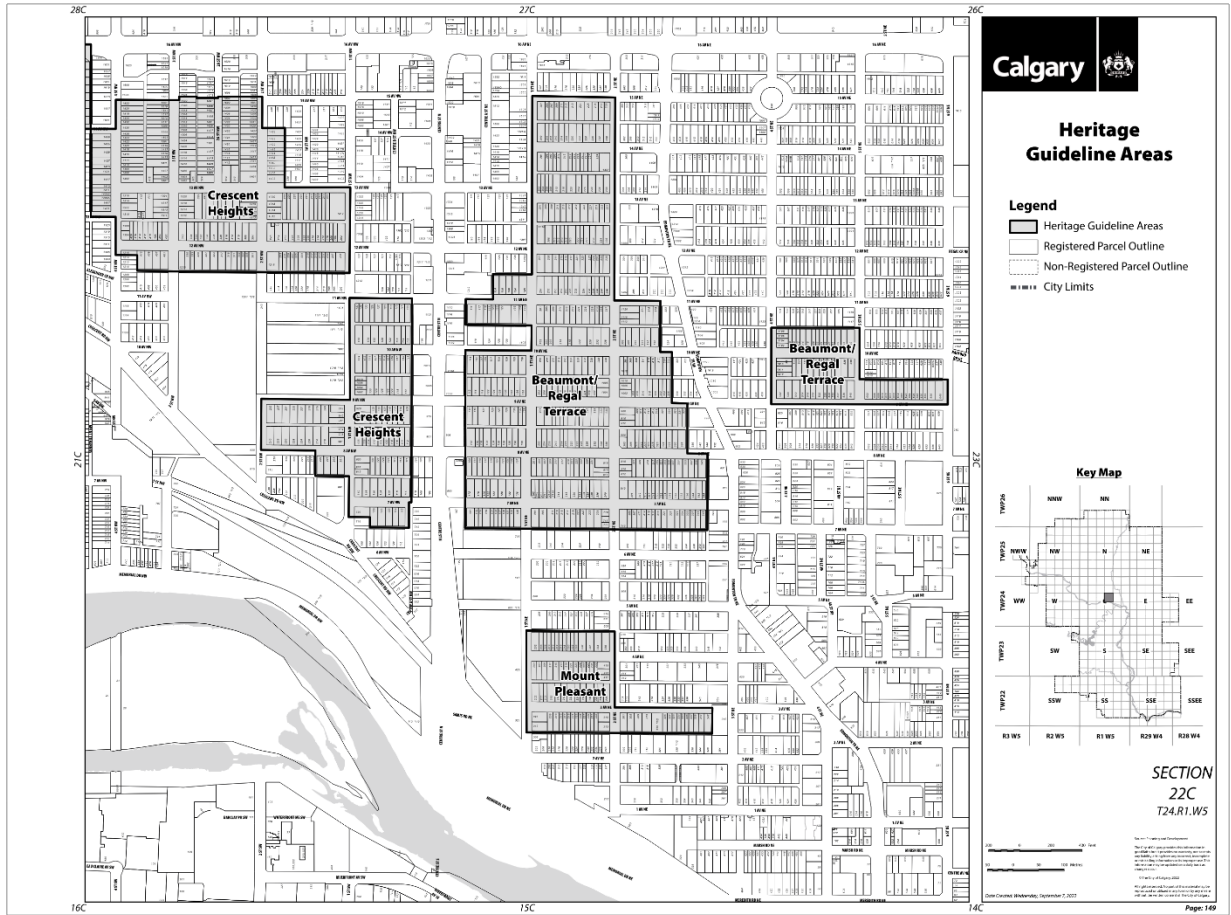

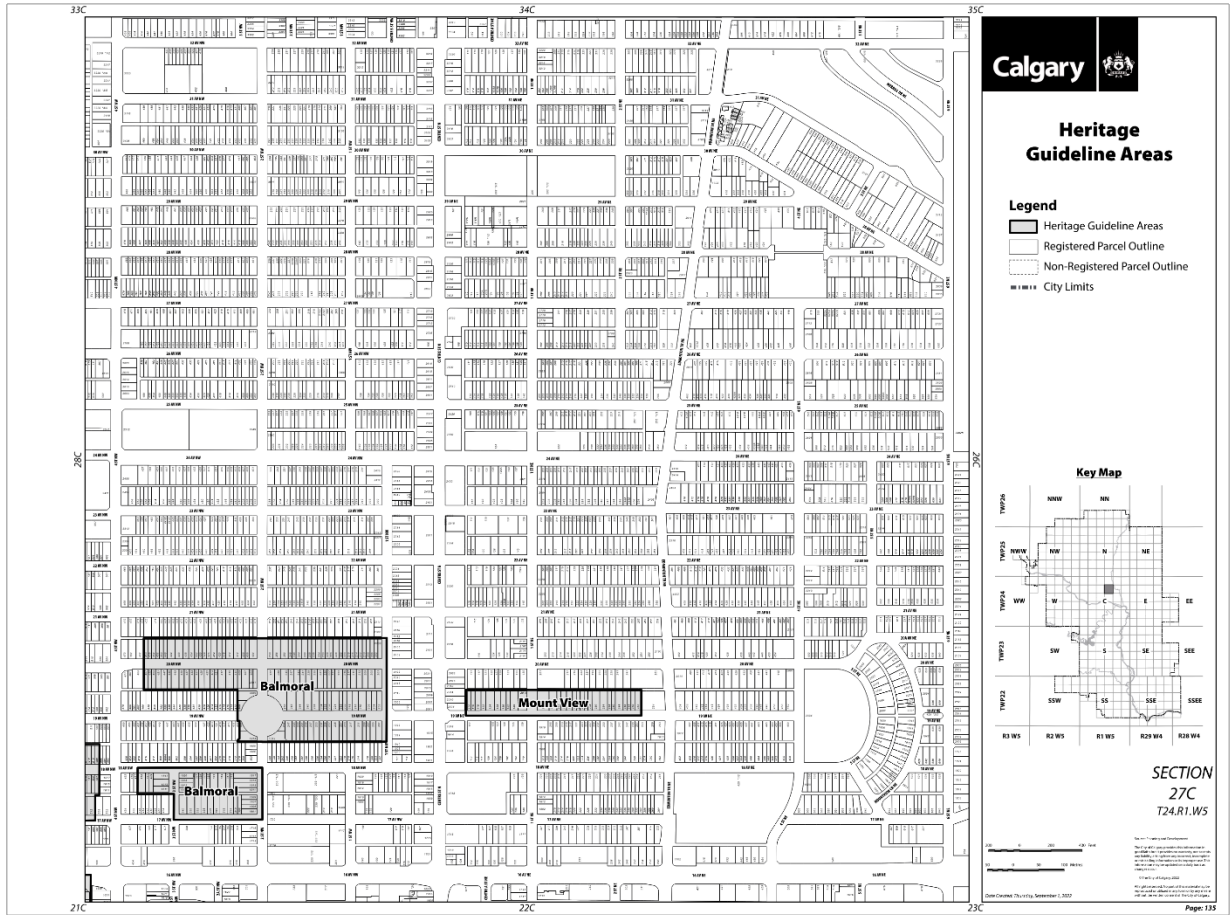
