#### **BYLAW NUMBER 53M2022**

### BEING A BYLAW OF THE CITY OF CALGARY TO AMEND BYLAW 11M2018, THE SUITE REGISTRY BYLAW

**WHEREAS** Council has considered IP2022-1224 and deems it necessary to amend Bylaw 11M2018, the Suite Registry Bylaw;

# NOW, THEREFORE, THE COUNCIL OF THE CITY OF CALGARY ENACTS AS FOLLOWS:

- 1. Bylaw 11M2018, the Suite Registry Bylaw, as amended, is hereby further amended.
- 2. Subsection 5.1 is deleted.
- 3. In section 7:
  - (a) in subsection 7(1)(b), the word "or" is deleted;
  - (b) in subsection 7(1)(c), the "." is deleted and replaced with "; or"
  - (c) after subsection 7(1)(c), the following is added as subsection 7(1)(d):
    - "(d) the suite has been removed from the structure in which it was located.".
- 4. The following is added after section 7 as section 7.1:

### "SUSPENSION OF REGISTRATION

- 7.1 (1) The *Director* may suspend a *suite* from the *Registry* if:
  - (a) an order pursuant to the <u>Safety Codes Act</u>, RSA 2000 c. S-1, for a breach of the Fire Code, Building Code or any other Code established by the *Act*;
  - (b) an order pursuant to the <u>Public Health Act</u>, RSA 2000 c.P-37, for a breach of the <u>Housing Regulation</u>, AR 173/99;
  - (c) an order pursuant to section 546 of the <u>Municipal Government</u> <u>Act</u>, RSA 2000 c. M-26;

is issued in respect of the *suite* or the structure in which the *suite* is located.

(2) The *Director* may cancel a suspension upon being satisfied that a breach identified in an order as set out in subsection (1)(a),(b) or (c) has been remedied.".
