HIGHLIGHTS

- Law supports the corporation's delivery of all services to people living and working in Calgary by addressing the corporation's insurance, claims and legal needs. Law also contributes to risk management and risk mitigation thereby enabling informed decision making within the corporate risk tolerance.
- Risk Management & Claims continues to monitor industry standard market trends, as it relates to the hardening Insurance markets. Globally many large Insurers have been risk averse towards increasing climate related exposures.
- Legal Services' highlights include supporting city building projects (e.g. Green Line, affordable housing initiatives and Downtown Calgary), ongoing implementation of Council's 2020 ZBR direction and handling of increasingly complex legal proceedings involving The City.
- Law formalized a Business Unit Equity, Diversity, Inclusion & Belonging Committee.
 Through a formalized program of activities, educational opportunities and cross corporate collaboration, the Committee is helping to advance our individual and collective journeys toward a more equitable, diverse and inclusive workplace and community.

DISCUSSION

Law includes Legal Services and Risk Management & Claims.

Legal Services is a full-service internal law department whose members are highly qualified legal professionals with diverse expertise and experiences, specializing not only in municipal legal matters but also the business of the corporation. Law's Risk Management & Claims Division delivers insurance and claims services to help customers identify, address and manage risk, manage The City's civic insurance program and work with the members of Legal Services to recover costs associated with damage caused to City assets. They also provide an avenue for people should they wish to submit a claim to The City.
