Friends of HMCS Calgary Committee

Background

The Friends of HMCS Calgary Committee ("the Friends of HMCS") was established by Council on 2020 May 12 with Notice of Motion PFC2020-0478. The mandate of the Friends of HMCS Calgary includes "...taking steps to celebrate and improve our unique Ship-City relationship; many Calgarians are unaware of our namesake ship and the work it does representing and projecting Canadian values on an international stage."

On 2022 March 29, Council considered Report CD2022-0060 and approved an amendment to the Friends of HMCS Terms of Reference. The amendment accounts for normal Navy operations and allows the Executive Officer to reassign the position on the Committee when required.

On 2022 November 1, Council appointed Lieutenant(N) Vincent Kam as the designate of the Executive Officer of the HMCS Calgary to complete a two-year term expiring in October 2024. On 2022 December 23, the City Clerk's office was informed by the Executive Officer of the HMCS Calgary that Lt(N) Kam was being replaced as designate by the individual named in Attachment 1, to complete a two-year term to expire at the 2024 Organizational Meeting of Council.

Anti-Racism Action Committee

Background

The Anti-Racism Action Committee ("the ARAC") advises Council and provides leadership on the development and implementation of a community-based anti-racism strategy. The ARAC monitors emerging community opportunities and challenges related to racism, identifies systemic barriers to accessing City of Calgary programs and services and recommends actions and opportunities to work with community partners and organizations on actions to address structural racism.

To fulfill its mandate, the ARAC's composition comprises a diverse and inclusive membership, consisting of:

- At least 11 and no more than 13 Calgarians with expertise in challenging structural racism and/or community organizing.
- Up to two non-voting member of The City of Calgary Senior Leadership.

On 2022 December 7, the ARAC administrative resource informed the City Clerk's Office of the resignation of Public Member Dahlia Khajeei from the ARAC.

Calgary Aboriginal Urban Affairs Committee

Background

The Calgary Aboriginal Urban Affairs Committee ("the CAUAC") provides Council with professional and strategic advice on matters that affect Aboriginal Calgarians and offers ongoing guidance in relation to the implementation of strategies that advance Aboriginal interests in ways that benefit all Calgarians.

The CAUAC's membership composition shall be a minimum of 12 members and a maximum of 14 members of the community, and at least 60 per cent plus one should be Aboriginal and will include one Aboriginal youth.

On 2022 December 14 and on 2023 January 12, the City Clerk's Office was informed of the resignations of public members from the CAUAC. With the two mid-term resignations, there are currently 12 members: eight Aboriginal and four non-Aboriginal members. The City Clerk's Office was provided with the name of one recommended candidate in Attachment 2 to fill one of the resulting vacancies, for completion of two-year terms expiring at the 2023 Organizational Meeting of Council. The CAUAC is not recommending filling the second vacancy at this time.
