- In 2022 December, Public Member Dhalia Khajeei resigned from the Anti-Racism Action Committee ("the ARAC") and Public Member Justin Jimmy resigned from the Calgary Aboriginal Urban Affairs Committee ("the CAUAC"). Public Member Earl Thiessen resigned from the CAUAC in 2023 January.
- Pursuant to section 5.18 of Council's Governance and Appointments of Boards,
  Commissions and Committees policy, Council may fill mid-term vacancies.
- What does this mean to Calgarians? Public Members on Boards, Commissions and Committees ("BCCs") contribute valuable skills and expertise.
- Why does this matter? Appointing new Public Members to fill mid-term vacancies supports capacity for BCCs to fulfill their mandates.
