## PREVIOUS COUNCIL DIRECTION / POLICY

At the 2012 December 02 Combined Meeting of Council, a Motion Arising with respect to PUD2012-0670 was carried. This directed Administration to report back to Council within 12 months of implementation of the Developer Funded ASP Pilot Project with an evaluation.

#### **BACKGROUND**

The first two Developer Funded ASPs (Cornerstone and Rangeview) began in 2013 October. Both ASPs were adopted on time, at the 2014 September 08 Combined Meeting of Council.

#### INVESTIGATION: ALTERNATIVES AND ANALYSIS

Consultation with internal and external stakeholders has been ongoing throughout the pilot project. Engaging those parties, determining lessons learned and evaluating the Pilot Project could not be comprehensively undertaken until pilot project completion. While the ASPs were approved by Council, completion of all pilot project tasks (pursuant to the Funding Agreement signed by The City and the Funders) will conclude on 2014 October 15. The Pilot is evaluated on metrics assigned to the full extent of project tasks, not solely on the adoption of the ASP itself.
