Re: Designation of the Gerlitz Residence as a Municipal Historic Resource

The Calgary Heritage Authority (CHA), in accordance with its role to advise Council and Administration on heritage matters in the City of Calgary, would like to take this opportunity to support the designation of the Gerlitz Residence, located in Inglewood, as a Municipal Historic Resource.

The Gerlitz Residence is listed on the CHA *Inventory of Evaluated Historic Resources* as a Community Historic Resource.

The Gerlitz Residence is a two-storey, wood-frame Edwardian Cottage with a medium-pitched, side-gable roof and a wide, shed-roofed front verandah. The front façade features a centred entry flanked by large, three-light picture windows and two vertical windows on the upper level. There is an original full-width, one-storey rear extension. The house is located on a residential street with a public boulevard planted with trees and shrubs. It is situated across the lane from 9 AV SE, a busy traffic corridor and historic streetcar commercial street, in the southeast inner city community of Inglewood, one of Calgary's earliest neighbourhoods.

The Norman and Jo Ann Stewart Residence is listed on the *CHA Inventory of Evaluated Historic Resources* as a City Wide Historic Resource.

The Norman and Jo Ann Stewart Residence, built in 1976, is a one-storey home faced in parged concrete and cedar planks, with a double-pitched, low-extending front gable roof and symmetrical facade with a central doorway topped by a large window. It has a moderate front set-back, with distinct rockery landscaping and a paved parking area, on a residential street in the southwest community of Glengarry.

The Calgary Heritage Authority (CHA), in accordance with its role to advise Council and Administration on heritage matters in the City of Calgary, would like to take this opportunity to support the designation of the Richard and Annie Taylor Residence, located in South Calgary, as a Municipal Historic Resource.

The Richard and Annie Taylor Residence is listed on the CHA *Inventory of Evaluated Historic Resources* as a Community Historic Resource.

The Richard and Annie Taylor Residence, constructed in 1912, is a one and one-half-storey, red-brick-clad, wood-frame Edwardian Cottage residence. Built in 1912, the gable-roof cottage is situated in a residential setting in the South Calgary community. The property is visually and historically related to two adjacent brick residences (1736 32 AV SW and 3214 17 ST SW), creating a unique and conspicuous grouping.
