BYLAW NUMBER 1B2019

**BEING A BYLAW OF THE CITY OF CALGARY
TO AMEND VARIOUS BYLAWS TO
REDUCE SURPLUS BORROWING AUTHORITY
IN THE TOTAL AMOUNT OF \$42,822,573**

WHEREAS Council of The City of Calgary (“Council”) duly passed the borrowing bylaws described in the attached Schedule “A” (“the Borrowing Bylaws”);

AND WHEREAS the Borrowing Bylaws authorized The City of Calgary to issue debentures to a total amount of \$104,503,367 to finance certain capital programs referenced in the Borrowing Bylaws (“the Capital Programs”);

AND WHEREAS debentures totalling \$61,680,794 have been issued against the Borrowing Bylaws;

AND WHEREAS the surplus borrowing authority for the Capital Programs as identified in the total amount of \$42,822,573 is no longer required;

AND WHEREAS it is deemed expedient by Council to pass a bylaw pursuant to Section 191 of the *Municipal Government Act* (R.S.A. 2000 c. M-26) to amend the Borrowing Bylaws by deducting the surplus authority in the total amount of \$42,822,573;

NOW, THEREFORE, THE MUNICIPAL COUNCIL OF THE CITY OF CALGARY, DULY ASSEMBLED, ENACTS AS FOLLOWS:

1. Each of the Borrowing Bylaws described in the attached Schedule “A” is hereby amended by reducing its authorized borrowing authority by the corresponding amount listed in Schedule “A”, for a total reduction of \$42,822,573.
3. The attached Schedule “A” is hereby declared to form part of this Bylaw.
